


SA1 General Progress

- Major focus remains on IMS and Messaging
- Completed the IMS scenarios TR 22.800
- Started the work on MBMS application level requirements
- Clarified support of emergency calls

Generic User Profile SWG

- 8 input documents, 1 output document
- The meeting agreed an update of the GUP WID.
 - This update contains changes already agreed in SA#19 which by mistake were not submitted to SA. The SWG additionally removed the reference to VHE
- It was not possible to agree clarifications on the requirements of the synchronisation of GUP components proposed S1-030726 (Nokia) and S1-030745 (Siemens)
- Four documents postponed to the next SWG meeting



IMS SWG summary

- Meeting finalised TR 22.800 on "IMS access scenarios and subscription" which is now ready for approval.
 - No conclusion on multiple IMS scenario, individual company's can bring WID according to normal procedures.
- CR agreed to 22.228 on Access Independence clarification
- CRs agreed to 22.101 related to USIM and ISIM.
 This is an alignment with changes to TS 33.203.
 - Note: The change to TS 33.203 was agreed in SA#20
- Agreed to draft a reply to LS on requirements on security for the MT reference point.



LCS SWG

- A great meeting with great contributions
- Discussions on charging for partially delivered assistance data.
- Agreed to remove requirement to identify LCS client with APN.
- Agreed a clarification of Mobile Originating Location.
- Discussions on QoS classes for LCS. Review needed in plenary.
- Agreed a requirement for authentication of the Target UE user.
- Replied to SA2 on Query, Cancel of activated location requests for the Target.



Messaging SWG (1)

- Progress was made in three areas:
 - Agreed Change Requests to allow storage of MMs on the UICC.
 - Completed handling of GSMA SerG MMS Service Requirements
 - Introduction of Hyperlinks into MMS.
- Work on the conditional delivery in MMS is ongoing, which has now been resolved.
- Task from TSG SA to review WID for MMS Rel-6 was completed and WID endorsed.



Messaging SWG (2)

Privacy SWG

- 13 participants from 12 companies
- 12 input documents, 1 output document for agreement (TR 22.949 v0.3.0)
- One incoming LS from SA3 requiring agreement to response.
 - The SWG could not agree a response as there was no agreed understanding of the "secure privacy domain". Participants invited to provide a simpler response direct to SA1 plenary
- Draft TR 22.949 progressed to version 0.3.0 (S1-030932)
 - Agreed that privacy information and personal data are the same thing.

- Produced version 1.0.0 of 22.246 (MBMS user services) for information at SA#21 (as of WID work plan)



Issues and progress reports

- Emergency calls handling and emergency calls numbers
- MBMS new stage 1





- R99 logic for the handling of emergency numbers was changed so that
 - only the numbers on the SIM/USIM are identified as valid
 - If the list of numbers in the SIM/USIM is empty then the numbers on the ME are considered
 - If there is no SIM/USIM the numbers on the ME are considered



- In earlier releases the list on the SIM was meant to contain additional emergency numbers only
- The result is that pre-R99 SIMs in R99 or later phones may not recognise some emergency numbers as valid.
- SA1 is proposing corrective CRs for this issue as per the following table

- 911 and 112 are now always available even if not in the (U)SIM list.
- Note that these are optionally recognised in R99 and Rel-4 terminals due to existing implementations of UEs
- It was also clarified that the additional numbers downloaded from the serving network are not available when a (U)SIM is not present.
- Release 6 paragraph was restructured for clarity



 Clarification of the support of emergency calls in IMS still under discussion





MBMS new stage 1 TS

- Still need to clarify:
 - Charging requirements
 - Roaming requirements
- A "reality check", particularly with GERAN is necessary to make sure that requirements can be met.

Other issues

- Emergency calls from (U)SAT
 - Still not possible to reach an agreement on the initiation of emergency calls from the USAT. A mismatch between stage 1 and 3 has been identified and it is planned to be resolved at the next SA1 meeting
- Storage of MM elements on USIM
 - Agreed a CR on the storage of MM elements on the USIM with one objection. Planned to continue working on the topic at the next SA1 meeting

- It was agreed to hold SA1 meetings as soon as possible after the TSG SA plenary so that early guidance can be given on issues requiring SA1 consideration
