ITU-T SG 13 “Future networks including mobile and NGN” thanks 3GPP for the input to our referencing Recommendations of Release 1999, Release 4, Release 5, Release 6, Release 7 and Release 8 in ITU-T Recommendations Q.1741.1, Q.1741.2, Q.1741.3, Q.1741.4, Q.1741.5 and Q.1741.6, respectively, and hopes to continue in the same way for the next Release. We have updated the work programme for Question 10/SG13 (Identification of evolving IMT-2000 systems and beyond) and have started with referencing of 3GPP Release 9. Our intention is that we will base our referencing on the different SDOs’ specifications derived from 3GPP Specifications. SG 13 would appreciate if these SDOs’ specifications refer to the same version of the 3GPP specifications. Our goal is to have the referencing Recommendation for Release 9 ready in Q4 2010. To fulfil this goal it is necessary that we receive information from you as early as possible and latest within the deadline indicated above. If possible, please forward the results in the format specified in Attachment 1. We would appreciate receiving a list of relevant 3GPP Rel-9 Specifications in advance, e.g. as at 3GPP TSG meetings #46, December 2009.

SG 13 asks 3GPP to provide us with new timing information of Release 9 in case the deadline indicated above could not be met.
