1 Introduction

Correspondence has been received from the newly created China Communications Standards Association, informing 3GPP of their creation and that they are now the parent organization of CWTS. The correspondence, which also contains a brief introduction to CCSA, is attached.

2 Action required by OP#9

The change of structure within China suggests that it is no longer appropriate for CWTS to be considered as the Organizational Partner in 3GPP but that this role should now be undertaken by CCSA.

The Organizational Partners are therefore requested to consider this application, to grant OP status to CCSA, and to remove that status from CWTS.

A signing ceremony to formalise these changes within the 3GPP Agreement will be conducted at a mutually convenient time.

(It should be noted that CCSA have agreed to provide a copy of their IPR Policy when it becomes available. They have indicated that the text will be virtually identical to that used by CWTS.)

1. Overview

2. Scope

The main scope is: to implement the laws, regulations and policies of the state standardizations; enhance exchange and understanding between the administrative authority and the members of CCSA; propose projects of producing and maintaining telecommunications standards; organize its members to participate in drafting standards; solicit views and opinions, coordinate, examine and review, conduct conformity, inter-connection and inter-operability testing; coordinate activities for submitting contributions to international standards organizations; provide standards promotion, consultation, service and training; promote implementation of standards; organize activities of international, regional and domestic seminars, cooperation and exchanges.

3. Membership

Any legal certified domestic entity that has been approved by Chinese government, including research and development institute, design institute, manufacture, operator, university and other organization, as well as joint venture, which accepts the statute of the Association, undertakes the obligation and relavent payment can apply for a member.

4. Organizational Structure

CCSA is structured by a General Assembly, a Board, Technical Committees and

Subcommittees, Experts Consultation Work Committees and a Secretariat as a permanent

operation organization.

Currently there are six Technical Committees under CCSA, including network and switching,

transmission and access network, wireless communication, IP and multimedia, network

management and power supply.
