Between 1996 and 2001, ITU-R Study Group 1 has developed and adopted a number of new or revised Recommendations dealing with unwanted emissions. These Recommendations cover spurious and out-of-band (OOB) emissions, the boundary between both domains, intermodulation, OOB falling into adjacent bands and a description of spectra and bandwidth of emission for modern modulation schemes.

The aim of this submitted frame or "roof" recommendation is to give guidance about the use of the whole package of ITU-R Recommendations and their relation to the ERC Recommendation 74-01 on unwanted emissions. This Frame Recommendation on Unwanted Emissions does not contain special limits for spurious or OOB domain emissions except for the determination of the boundary between the out-of-band and spurious domains for Radars using the limits given in the ERC Rec 74-01 corresponding to the Category B limits in ITU-R Rec. SM.329-9.

It is the intention of WG SE to approve the "roof" recommendation and the revised ERC Recommendation 74-01 in the next WG SE meeting in Baden, Austria (10 –14 June 02).

Therefore, WG SE would like to invite ETSI/ERM and ERM/RM to consider the attached new draft ECC Recommendation.

Draft CEPT/ECC/Recommendation UNWANTED EMISSIONS

Introduction

Between 1996 and 2001, ITU-R Study Group 1 has developed and adopted a number of new or revised Recommendations dealing with unwanted emissions. These Recommendations cover spurious and out-of-band (OOB) emissions, the boundary between both domains, intermodulation, OOB falling into adjacent bands and a description of spectra and bandwidth of emission for modern modulation schemes. Special attention was paid to the protection of Passive and Safety Services from unwanted emissions.

The aim of this frame or "roof" recommendation is to give guidance about the use of the whole package of ITU-R Recommendations and their relation to the ERC Recommendation 74-01 on unwanted emissions. This Frame Recommendation on Unwanted Emissions does not contain special limits for spurious or OOB domain emissions. Fig. 2 illustrates the frame or "roof" concept of this Recommendation.




Figure 1: Illustration of the OOB and Spurious Domains (not part of ITU-R Rec. SM.329)

Unwanted emissions are composed of OOB and spurious emissions as defined in Article S1, No. S1.144-146 of the RR. OOB and spurious emissions as defined there are outside the necessary bandwidth. However, according to Appendix S3 of the RR (WRC-2000) and to ITU-R Rec. SM.329, the spurious domain emission limits are generally applicable for frequency ranges larger than 250 % of the necessary bandwidth. A new terminology, the domain concept, is introduced, the definition of out-of-band and spurious domains which overcomes this aforementioned contradiction. This terminology and the relevant definitions are given ITU-R Rec. SM.329-9 and reproduced in Annex 1 for information and are illustrated in Fig. 1:

Note: The crossover point between OOB and Spurious emissions is not defined and Fig. 1 shows only an example.




Figure 2: Frame or "roof" structure of this ERC Rec.

"The European Conference on Postal and Telecommunications Administrations,

considering

- a) that the Radio Frequency spectrum is a common resource and it is necessary to keep it as unpolluted as possible, making the best use of the most modern and cost-effective techniques;
- b) that a number of ITU-R Recommendations are available for protection of other radio systems and services from unwanted emissions:
- c) that Recommendation ITU-R SM.329 (Unwanted Emission in the Spurious Domain) relates to effects, measurements, generic and specific regional limits to be applied to unwanted emissions in the spurious domain;
- d) that Recommendation ITU-R SM.1541 (Unwanted Emissions in the Out-of-band Domain) relates to effects, measurements and broadly generic limits to be applied to unwanted emissions in the out-of-band domain;
- e) that the Recommendations ITU-R SM.329 and SM.1541 provides guidance for determining the boundary between the out-of-band and spurious domains in a transmitted radio frequency spectrum;
- f) that Recommendation ITU-R SM.1539 deals with variation of the boundary between the outof-band and spurious domains required for the application of the Recommendations ITU-R SM.329 and SM.1541;
- g) that Recommendation ITU-R SM.1540 covers unwanted emissions in the out-of-band domain falling into adjacent allocated bands;
- h) that the protection of the Passive Services is covered by Recommendation ITU-R SM.1542;
- i) that the protection of the Safety Services is covered by Recommendation ITU-R SM.1535;
- j) that the Recommendation ITU-R SM.326 deals with intermodulation products generated in amplitude-modulated radio transmitters;
- that the Recommendation ITU-R SM.1446 deals with definition and measurement of intermodulation products in transmitters using frequency, phase or complex modulation techniques and related background information and mitigation techniques are provided in the ITU-R Report SM.2021;
- 1) that Recommendation ITU-R SM.328 gives definitions and explanatory notes which should be used when dealing with spectra and bandwidth of emissions;

recommends

- 1. that the ITU-R Recommendations on unwanted emissions should be used as general guidance;
- 2. that the limits for the unwanted emission in the spurious domain (spurious domain emission limits) should be according to the ERC Recommendation 74-01 that corresponds to the Category B limits in ITU-R Rec. SM.329 and has been derived taking into account ETSI standards;
- 3. that the limits for the unwanted emission in the out-of-band domain (out-of-band domain emission limits) should be intended as generic limits, which generally constitute the least restrictive out-of-band domain emission limits successfully used in national or regional regulations², and that they are covering all limits provided by ETSI standards, where, in general, more stringent or at least equal limits are given [and should be met]³;
- 4. that the variation of the boundary between out-of-band and spurious domains should be according those generally covered by ITU-R Rec. SM.1539 except the boundary for Radar systems designed for Category B spurious domain emission limits, for which guidance is provided in Annex 2;
- 5. that ITU-R Rec SM.1535 and SM.1542 should be used for generic mitigation techniques for reduction of unwanted emissions.

ANNEX 1 (informative)

TERMINOLOGY AND DEFINITIONS USED IN ITU-R REC. SM.329

The following terms and definitions complement those already defined in the Radio Regulations (RR). (Definitions shown in *italics* are a direct quotation from the RR.)

1 Spurious emission (Article S1, No. S1.145 of the RR)

Emission on a frequency, or frequencies, which are outside the necessary bandwidth and the level of which may be reduced without affecting the corresponding transmission of information. Spurious emissions include harmonic emissions, parasitic emissions, intermodulation products and frequency conversion products but exclude out-of-band emissions.

1.1 Harmonic emissions

Spurious emissions at frequencies which are whole multiples of the centre frequency emissions.

1.2 Parasitic emissions

Spurious emissions, accidentally generated at frequencies which are independent both of the carrier or characteristic frequency of an emission and of frequencies of oscillations resulting from the generation of the carrier or characteristic frequency.

1.3 Intermodulation products

Spurious intermodulation products result from intermodulation between:

- the oscillations at the carrier, characteristic, or harmonic frequencies of an emission, or the oscillations resulting from the generation of the carrier or characteristic frequency; and
- oscillations of the same nature, of one or several other emissions, originating from the same transmitting system or from other transmitters⁴ or transmitting systems.

1.4 Frequency conversion products

Spurious emissions, not including harmonic emissions, at the frequencies, or whole multiples thereof, or sums and differences of multiples thereof, of any oscillations generated to produce the carrier or characteristic frequency of an emission.

2 Out-of-band emission (Article S1, No. S1.144 of the RR)

Emission on a frequency or frequencies immediately outside the necessary bandwidth which results from the modulation process, but excluding spurious emissions.

3 Unwanted emissions (Article S1, No. S1.146 of the RR)

Consist of spurious emissions and out-of-band emissions.

4 Out-of-band and Spurious domains

The terms "out-of-band domain" and "spurious domain" have been introduced in order to remove some inconsistency between, on one hand, the definitions of the terms "out-of-band emission" and "spurious emission" in Article S1 of the Radio Regulations and, on the other hand, the actual use of these terms in Appendix S3 of the Radio Regulations, as revised by WRC-2000. Out-of-band and spurious domain emission limits apply, respectively, to all unwanted emissions in the out-of-band and spurious domains.

4.1 Out-of-band domain

(of an emission): The frequency range, immediately outside the necessary bandwidth but excluding the *spurious domain*, in which *out-of-band emissions* generally predominate.

4.2 Spurious domain

(of an emission): The frequency range beyond the *out-of-band domain* in which *spurious emissions* generally predominate.

NOTE – Out-of-band *emissions*, defined based on their source, occur in the out-of-band domain and, to a lesser extent, in the spurious domain. Spurious emissions likewise may occur in the out-of-band domain as well as in the spurious domain.

5 Necessary bandwidth (Article S1, No. S1.152 of the RR)

For a given class of emission, the width of the frequency band which is just sufficient to ensure the transmission of information at the rate and with the quality required under specified conditions. For application to multi-channel or multi-carrier transmitters/transponders, where several carriers may be transmitted simultaneously from a final output amplifier or an active antenna, the necessary bandwidth is taken to be the transmitter or transponder bandwidth, as its 3 dB bandwidth. This does not apply to base stations in the mobile service or to fixed wireless access base stations using mobile technology.

For fixed service, Recommendation ITU-R F.1191 is to be used to calculate the necessary bandwidth in the case of fixed digital radio multi-carrier systems.

For the radiodetermination service, the necessary bandwidth of frequency-agile radars is taken to be the part of the allocated band over which the carrier frequencies of those radars tune.

ANNEX 2

BOUNDARY AND LIMITS FOR PRIMARY RADAR

This Annex defines limits for unwanted emissions in the out-of-band domain for fixed radar stations for which ERC Rec. 74-01 applies the more stringent Category B Limits of ITU-R Recommendation SM.329. By providing these limits the boundary between the out of band domain and the spurious domain is defined.


The limits of unwanted emissions in the out-of-band domain for any other radar systems are given in Annex 8 of ITU-R SM.1541.

Two spectrum masks are given, one based on the roll-off of 20 dB/decade and one based on the design objective both taken from the Rec. ITU-R SM.1541. The mask based on an initial 20 dB roll off is applicable to all Radars which fall under this Annex. New radar design should aim to meet the design objectives as soon as possible. In the future it is intended to apply a more stringent mask based upon the design objective.

The two masks are as shown in Figure 1 below.

Figure 1: Emission Mask for Radars

The dashed line is the limit for unwanted emissions in the out of band domain. The solid line represents the proposed design objective.



For the Category B limit the mask rolls off at 20dB per decade from the calculated 40 dB Bandwidth (B_{-40}) to a level of $-60 \ dB_{pp}$. The limit continues to roll off at 60 dB per decade to the -100 dB level. For the design aim the mask rolls off at 40dB per decade from the calculated 40dB Bandwidth to a level of $-80 \ dB_{pp}$. The limit continues to roll off at 60 dB per decade to the -100 dB level. The equations for determining the 40 dB bandwidth are given in Annex 8 of ITU-R SM.1541.

The limit will result in the out of band emission domain of 46.4 times B_{-40} . The design objective will reduce the out of band emission domain to 21.5 times B_{-40} .

These two masks have the characteristics listed in the following Tables. The limits are given as a multiple of the frequency of the 40 dB bandwidth excursion.

Dear Olly,

The ERC Rec 74-01 contains the European limits and definitions for spurious emissions and corresponds to ITU-R Rec SM.329 which was revised in 2000 by ITU-R SG1 and is now finally approved (Administrative Circular CACE/222). Consequently, the ERC Rec 74-01 is being revised within the SE Project Team 21.

The main modifications are related to:

- the introduction of a new terminology for unwanted emissions occurring in the out-of-band and spurious domains to overcome some possible misunderstandings in Article S1 and Appendix S3 of the Radio regulations,
- the update of ERC Rec 74-01 with the outcome of the recent WRC-2000 and the Rec SM.329-9 and SM.1539
- some specific comments to Fixed Service and Radar.

It should be emphasised that there are no substantial changes in the limits.

Following to the CEPT ETSI MoU, a regular review in the light of the changing technologies and regulatory requirements with a period of 3 years was agreed and stated in the Foreword of this ERC Rec 74-01, that means 2002.

Therefore, WG SE would like to invite ETSI/ERM to consider the attached draft revision of the ERC Recommendation.

It is envisaged to complete the revision of ERC Rec 74-01 together with a new "frame" Recommendation dealing with the relation of all effects of unwanted emission in the early next year. In order to accelerate this process, all comments and suggestions from ETSI/ERM should be directly directed to PT SE21.

The next meetings of SE21 are scheduled at 23-25 October 2001 in Brest, 4-6 December 2001 in Copenhagen and 26-28 February 2002.

Draft Revision of CEPT/ERC/RECOMMENDATION 74-01E (Siófok 1998, Nice 1999)

SPURIOUS EMISSIONS¹

Recommendation proposed by the Working Group "Spectrum Engineering" (WGSE)

Text of the Recommendation adopted by the "European Radiocommunications Committee" (ERC):

Foreword

This Recommendation specifies the limits of the unwanted spurious emission limits in the spurious domain (spurious limits) for different services and types of equipment. It should be used as a generic guide when drafting new, and revising ETSI standards, and also for guidance to administrations in the absence of relevant standards. It should not be used as a stand-alone document for the purpose of type approval.

It is recognised that certain existing ETSI standards and a limited number of those in an advanced stage of preparation do not fully align with this Recommendation. Where, for historical reasons, such existing standards do not align with this Recommendation, the spurious emission—limits should be reviewed if revisions are considered. It is also recognised that, largely as a consequence of new technologies emerging, it may be acceptable that specific standards adopt limits which differ from this Recommendation; these are listed in Annex 8.

Where a difference between the limits for a particular standard and this Recommendation might exist, the limits should be agreed following the iterative, consultative procedure given in the ETSI/ERC Memorandum of Understanding¹ (ref. ETSI Collective Letter no. 866 of 26 Jan. 942). This procedure should consider the interaction between technical parameters, spectrum efficiency, regulatory and economic aspects.

Where there is a difference between the limits for a particular standard and this recommendation CEPT assumes the following procedure would be useful:

- The relevant technical bodies in ETSI² and CEPT³ will agree to exchange liaison statements to each other whenever they believe changes to this recommendation, an ETSI standard, or the inclusion of a standard into **Annex 8** is required;
- The ETSI liaison statement should be supported by appropriate technical justification and other relevant information. This should include information on economic and market related issues concerning the proposal. In addition ETSI should also provide any information on system spectrum efficiency that they may have available to support their case;
- The CEPT liaison statement should include the implications of the proposal on spectrum engineering parameters such as: effective use of the spectrum, requirements of existing services, sharing/adjacent band and other regulatory issues;
- The proposal should be considered in the spirit of the CEPT/ETSI MoU with dialogue, full consultation and an iterative process if necessary. Ideally this process should be completed within 6 months;

- The conclusions should be mutually acceptable and neither party should feel that its views have been disregarded;
- When consensus is achieved the results should be recorded in a revision of this recommendation or revision of the appropriate standard.

It is considered appropriate that this Recommendation should be reviewed every three years, in the light of changing technologies and regulatory requirements. This review should involve consultation with the relevant technical and working groups within CEPT and ETSI.

"The European Conference of Postal and Telecommunications Administrations,

considering

- a) that the <u>r</u>Radio <u>f</u>Frequency spectrum is a common resource and it is necessary to keep it as un-polluted as possible, making the best use of the most modern and cost-effective techniques;
- b) that it is important for CEPT countries to define common limits of <u>unwanted spurious</u> emissions <u>in the spurious domain</u> for all services that may be placed in operation;
- c) that detailed and specific sharing or compatibility studies may lead to different limits and definitions for the <u>unwanted spurious</u> emissions <u>in the spurious domain</u> from the systems concerned; however these are not in the scope of this recommendation which aims to provide a specific minimum requirement;
- d) that ITU-R Recommendation SM.329 provides options for different categories of limits for <u>unwanted emissions</u> in the spurious <u>domain emissions</u>; moreover it provides some degree of freedom to Administrations, for the defined frequency boundaries for the definition of spurious <u>emissions domain</u> and the detailed transition of the limits nearby the fundamental emission; in particular it allows, for digital modulations, definitions, for spurious emissions frequency boundaries, <u>other than the specific ± 250% of the Necessary Bandwidth from the centre frequency of the emission;</u> however it gives allowance for different definitions when practical;
- e) that ITU-R Recommendation SM.1539 deals with variation of the boundary between the out-of-band and spurious domains, other than the specific ± 250% of the Necessary Bandwidth from the centre frequency of the emission;
- e)f) that a revised appendix S3 has been approved at WRC'97, containing new limits mandatory from 2003;
- that the Radioastronomy Service, the Earth Exploration Satellite Service and the Meteorological Satellite Service using passive sensors are particularly sensitive to interference due to their wide frequency coverage and the weakness of the signals they detect. These limits are far lower than the spurious emission limits considered practicable at the antenna port of most transmitters, therefore the protection of these services depends on additional mitigating factors such as antenna decoupling and spatial separation;
- gh) that there may be cases where a permanent source of interference, for example a radar or broadcast transmitter in the near vicinity, or spurious emissions generated at the radio transmitter site due to the interaction amongst various transmitters operating at the same time, cause unacceptable performance degradation to a victim receiver. These cases are considered site engineering problems and are not in the scope of this recommendation provided that it is possible to use special protection applied to either the source of interference, or the victim, or both;
- that CEPT and ETSI have developed a Memorandum of Understanding describing the relative responsibilities of the two bodies. The MoU text is available from the ERO;
- that within CEPT/ERC, a statistical simulation methodology based on the 'Monte Carlo' method has been developed and accepted as the basis for the future development of a software tool to enable the assessment of the effect of spurious limits in terms of probability of interference. The tool developed for ERC

will be made available under the conditions of the MoU on development of the Monte Carlo simulation tool. The text of this MoU is available from the ERO;

- that <u>unwanted Spurious e</u>Emissions may be delivered to the antenna port with consequent radiation from the antenna or produced by direct unwanted radiation from the system enclosure, due to insufficient shielding; however the latter effect is outside the scope of this recommendation;
- that fast switching transients of burst transmission systems may produce specific spurious emission patterns with high peak factor, which may affect victim receivers more severely than that due only to the spurious emissions associated with the average power during the burst duration;
- that transmission systems may be coupled to an "Active Antenna System" which may further contribute to generate spurious emissions;
- Note: an "Active Antenna System" (AAS) is an antenna with embedded capability for electronic amplification and/or other RF processing. The total gain of an AAS may be functionally split into an "active" gain of the electronic functions (AG) and a conventional "passive" gain/loss (directivity) due to the geometrical design performance of the antenna (PG).
- n) that receivers may also radiate spurious components from the antenna, which are presently not covered by ITU-R Recommendation SM.329;

recommends

- 1. that spurious emission-limits of unwanted emissions in the spurious domain apply at frequencies above and below the fundamental transmitting frequency but separated from the centre frequency of the emission by 250% of the necessary bandwidth. However, this frequency separation may be dependent on the type of modulation used, the maximum bit rate in the case of digital modulation, the type of transmitter, and frequency coordination factors. For example, where practical the ± 250% of the relevant Channel Separation (CS) may be used.
- Note 1: According to the Radio Regulations, the <u>n</u>Necessary <u>b</u>Bandwidth is, for a given class of emission, the width of the frequency band which is just sufficient to ensure the transmission of information at the rate and with the quality required under specified conditions. However, the necessary bandwidths of most digital modulation formats are presently not referred to <u>in</u> ITU-R Recommendations of SM series.
 - Note 2: Considering the flexibility allowed by ITU-R Recommendation SM.329 on the 250% boundary definition, it is recognised that this figure may be appropriate for medium-band systems, while the physical constraint of filtering in narrow-band systems and the resulting amount of spectrum polluted by wide-band systems may require further adaptation (e.g. by a wider or a reduced percentage, respectively), [however this will require further study; therefore the 250% figure for narrow-band and wide band systems is considered provisional]ITU-R Recommendation SM.1539 gives guidance on the boundary variation in these cases.
 - Note 3: In ITU-R Recommendation SM.329 the spurious domain (of an emission) is defined by the frequency range, beyond the out-of-band domain, in which spurious emission generally dominate.
- 2. that for the purpose of this recommendation, only unwanted Spurious eEmissions in the spurious domain conducted to the antenna port or subsequently radiated by any integral antenna, are subject to the required limits;

3. that the <u>spurious</u> limits <u>on spurious emissions</u> for radio equipments are considered here to be applicable to the range 9 kHz to 300 GHz. However, for practical measurement purposes only, the frequency range of spurious emissions may be restricted. As guidance for practical purposes, the following measurement parameters are normally recommended:

These parameters reflect the increasing difficulty in undertaking practicable tests, especially at frequencies approaching or beyond 110 GHz, taking into account such factors as availability and usability of suitable measurement equipment. In some circumstances, it may be necessary to extend the range of test frequencies in order to facilitate better protection of other services such as Radioastronomy. In any case, systems having an integral antenna incorporating a waveguide section, or with an antenna connection in such form, and of length equal to at least twice the cut-off wavelength, should not require spurious emissions measurement below 0.7 times the waveguide cut-off frequency;

Note: Further simplifications of measuring techniques to achieve time/cost savings, while still guaranteeing the fulfillment of the requirement, are outside the scope of this Recommendation, but may be taken from the relevant system ETS-EN or Conformance Test Standards when available.

- 4. that the following reference bandwidths should are to be used:
- 1 kHz between 9 and 150 kHz
- 10 kHz between 150 kHz and 30 MHz
- 100 kHz between 30 MHz and 1 GHz
- 1 MHz above 1 GHz
- Note 1: A reference bandwidth is a bandwidth in which the spurious domain emission level is specified.
 - Note 2: Some services may use, close to the carrier, reference bandwidth values different from the above; these differences are quoted in the relevant service Annex.

As a special case, the reference bandwidth of all space stations' spurious domain emissions should be 4 kHz.

The reference bandwidths required for proper measurement of radar spurious <u>domain</u> emissions <u>should</u> <u>must</u> be calculated for each particular radar system, and the measurement methods should be guided by Recommendation ITU-R M.1177. Thus, for the three general types of radar pulse modulation utilised for radionavigation, radiolocation, acquisition, tracking and other radiodetermination functions, the reference bandwidth values in MHz should be:

- A) for fixed frequency or non pulse coded radar, the reciprocal of the radar pulse length in microseconds (e.g. if the radar pulse length is 1 microsecond, then the reference bandwidth is $1/1\mu s = 1$ MHz);
- B) for fixed frequency, phase coded pulsed radar, the reciprocal of the phase chip length in microseconds (e.g. if the phase coded chip is 2 microseconds long, then the reference bandwidth is 1/2µs = 0.5 MHz);
- C) for Frequency Modulated (FM) or chirped radar, the square root of the quantity obtained by dividing the swept frequency range in MHz by the pulse length, in microseconds (e.g. if the swept frequency range is from 1250 to 1280 MHz or 30 MHz during the pulse of 10 microseconds, then the reference bandwidth is (30 MHz / 10μ).

As a general rule, the resolution bandwidth of the measuring receiver should be equal to the reference bandwidth as given in this recommend. To improve measurement accuracy, sensitivity and efficiency, the resolution bandwidth can be different from the reference bandwidth. When the resolution bandwidth is smaller than the reference bandwidth, the result should be integrated over the reference bandwidth. When the resolution bandwidth is greater than the reference bandwidth, the result for broadband spurious emissions should be normalised to the bandwidth ratio. For discrete spurii, normalisation is not applicable, while integration over the reference bandwidth is still applicable;

- 5. that the levels of spurious domain emissions should be defined within a reference bandwidth;
- 6. that the appropriate spurious emissions limit is to be applicable to all services as detailed by **Table 1**. Unless PEP is explicitly quoted the spurious emission limits, quoted in **Table 1**, from the transmitter into the antenna port are in terms of mean power. The mean power (P) of any spurious domain transmission from a burst transmitter is the mean power averaged over the burst duration.
- Note 1: in special cases such as those referred by considering sh, tighter limits may be required.
 - Note 2: It is recognised that, in principle, in some cases of narrowband and/or high power transmitters for all categories of services, there may be objective difficulties in meeting limits close to +/- 250% of the necessary bandwidth; these cases are reported in the specific annexes summarised in **Table 1**.
- Note 3: when a system is coupled to an "Active Antenna System", the limits of **Table 1** should be met by the combined system; therefore compliance should be verified through an e.i.r.p. measurement (either near-field or far-field) and subsequent conversion to absolute power/attenuation values delivered to the transmission line, taking into account only the conventional "passive" gain (directivity) of the antenna.
- 7. that for fast switching induced spurious <u>domain</u> emissions, an additional limit for their peak power will be necessary, however further study should be carried on to investigate the nature of the phenomenon prior to fixing specific limits;
 - 8. that, the limits specified within this Recommendation should be considered for new ETSI standards developed after the date at which the Recommendation is adopted.

In the case where the limits referred to in this Recommendation are found to be more stringent than existing ETSI Standards (TBR/ETS/EN/ES) a revision process may need to be considered. If revised, the standard should, whenever technically and economically feasible, meet the limits in this Recommendation.

Where either CEPT or ETSI consider the limits defined in this Recommendation are inappropriate for a particular standard an agreement on alternative limits should be reached by application of the MoU between ETSI and CEPT as published by ERO. A list of such agreements is given in Informative **Annex 8**;

- 9. that for all aspects not covered in this recommendation, ITU-R Recommendation SM.329 should apply; however, where applicable, ETSI standards or ITU-R Recommendations, if any, should be taken into account for methods of measurements of specific services;
- 10. that Administrations should afford all practicable protection to the frequencies utilised by the services using passive sensors referred to in considering fg) (Annex 7 reports interference threshold values for these services, as referred by the relevant ITU-R recommendations). In bringing new services into operation, administrations are urged to note that transmitters can cause severe interference to other services through their spurious and out-of-band emissions, including far sidebands;
- 11. that for receivers any exclusion, such as 250% of the necessary bandwidth, quoted in recommends 1 should not apply. Measurements should be made in accordance with recommends 3 where the fundamental frequency range should include the highest oscillator frequency used in the receiver and the harmonics are those of the highest oscillator frequency.
- 12. that the active state of a transmission station is defined as the state which produces the authorised emission.
- 13. that the idle/standby state of a transmission station is defined as the state where the transmitter is available for traffic but is not in the active state.

ANNEX 1

FIXED SERVICE SPECIFIC REQUIREMENTS

1. Informative background

Fixed Service Digital Radio Relay Systems presently referred to in the specific ETSI TM4 work programmes, and used in CEPT countries, cover a very wide range of frequency bands of emission, traffic capacity, channel separations and modulation formats of which typical parameters are as follows:

frequency band from below 1 GHz to 58 GHz traffic capacity from 9.6 kbit/s to 622 Mbit/s channel separations from 25 kHz to 220 MHz

modulation formats from 2 to 1024 states (amplitude and/or phase and/or frequency states).

Analogue TV are the main analogue Radio Relay Systems of practical interest still placed in operation in the above frequency band; the necessary bandwidth of such analogue TV is not defined in any ITU-R Recommendation and, moreover, a wide variety of above-video sub-carriers are usually added to the main TV carrier.

2. Limits

ITU-R Recommendation F.1191 requires that, for Digital Radio Relay-Systems, operating on a specific radio-frequency channel arrangement, the frequency boundaries between spurious and out-of-band domainsemissions are \pm 250% of the relevant Channel Separation (CS). Therefore, for the purpose of this recommendation, the frequency boundaries for spurious domain emissions of analogue and digital fixed service systems are taken, whenever applicable, as \pm 250% of the relevant CS of the radio-frequency channel arrangement where the system is to be placed.


According to ITU-R Recommendation F.1191, the Channel Separation (CS) is taken as *XS*/2 for alternated frequency channel arrangements and *XS* for co-channel and interleaved frequency channel arrangements as defined by ITU-R Recommendation F.746.





APPLICATION OF REFERENCE BANDWIDTHS TO DIGITALLY MODULATED AND NARROW-BAND HIGH POWER ANALOGUE MODULATED MOBILE SERVICES

Narrow-band analogue modulated systems, with output power higher than 1 Watt and operated above 30 MHz, and digitally modulated systems although generally providing good spectrum efficiency, are unable to comply with the above limits for close-in frequencies due to the wideband noise generated by such systems. It is therefore necessary to provide specific steps of reference bandwidth in order to produce suitable transition area for the spectral density.

The specific reference bandwidth mask is shown in **Figure 2.1** for frequencies below 1 GHz and in **Figure 2.2** for frequencies above 1 GHz, with frequency limits which are a function of the channel separation or the necessary bandwidth (NB).

These masks apply to both mobile terminals and base stations.





ANNEX 5

RADAR SYSTEMS IN THE RADIODETERMINATION SERVICE SPECIFIC REQUIREMENTS

The term "radiodetermination" includes (aeronautical and maritime) radionavigation and radiolocation for terrestrial and satellite services, examples are given in Figure 5.1. The radar systems used in these various services require special limits for spurious domain emissions.

Radars used in the radiodetermination service often require high e.i.r.p. to perform their missions and therefore special care is necessary to fulfil the requirements of other services in order to ensure compatibility with services in adjacent bands.

Spurious emissions—limit for radiodetermination systems should take into consideration the platform type and mission of the radar. Limits for radiodetermination are divided into those for fixed stations and those for mobile stations as indicated in the table below.

Owing to the different types of modulation (fixed frequency radars, non-pulse-coded radars, phase-coded pulsed radars and swept-frequency such as FM or chirp radars) the spurious limits should be measured at the antenna output (radiated) as guided by the methods set out in ITU-R Recommendation M. 1177. The measurement methods and spurious emission-limits shall take account of the attenuation of spurious domain emissions by the antenna.

The necessary reference bandwidths of the spurious emissions are indicated <u>funder "recommend 4_or_by Rec M.1177]." of this Recommendation</u>.

The limits in the table below are minimum levels applicable to radars for radiodetermination. Except where otherwise provided by special recommendations the limits for "navigation aids" in the radionavigation service are the same as for those in the (aeronautical and maritime) mobile services.

Note: Radiolocation radars, deployed in SRD bands, are not subject to requirements of this annex; SRD limits in annex 2 should apply]



ANNEX 7 (INFORMATIVE)

THRESHOLD LEVELS OF INTERFERENCE FOR THE RADIO ASTRONOMY SERVICE AND SPACE SERVICES USING PASSIVE SENSORS

This annex reproduces the content of **Annex 3** and **Table 4** of ITU-R Recommendation SM.329–7. When further information is required, the latest version of that Recommendation should be consulted.

1 Introduction

Threshold levels of interference for the radio astronomy service, Earth exploration-satellite and meteorological-satellite services using passive sensors can be found in Recommendations ITU-R RA.769 and SA.1029. This Annex summarises the levels provided in these Recommendations.

2 Radio astronomy service (Recommendation ITU-R RA.769)

Table 7.1 gives the threshold levels of power flux density (pfd) and spectral power flux density (spfd) for interference detrimental to the radio astronomy service. These are calculated for observations with a single antenna and reception in sidelobes of gain 0dBi and an integration time of 2000 sec. The values of pfd and spfd given in **Table 7.1** apply generally, except for GSO satellites for which the pfd is 15 dB more stringent than shown (see Recommendation ITU-R RA.769-1).

Annex 1 to Recommendation ITU-R RA.769 describes the methodology for calculating the sensitivity of various radio astronomy systems currently in use. It also provides, for assumed values of system parameters, tabulated levels of aggregate interference which are detrimental to both continuum and spectral-line measurements for various bands allocated to the radio astronomy service.

The assumed parameters used to derive these levels are representative of many types of radio astronomy systems and measurements and are an agreed acceptable standard within the radio astronomy service. However, there may be circumstances in coordination with a specific radio astronomy system, operating at a particular time and location in a particular band, where other values of these parameters may be used with the same methodology to derive a more appropriate level of detrimental interference. In addition, for consideration of interference from specific types of systems (e.g. GSO satellites or multiple-satellite systems) a systematic adjustment of the levels in Recommendation ITU-R RA.769 may be warranted. Accordingly, when the levels contained in Table 7.1 are applied or referred to, account should be taken of the assumptions used to derive them.

Annex 7

3 Earth Exploration-Satellite and Meteorological-Satellite passive sensing (Recommendation ITU-R SA.1029)

The permissible interference levels in Table 7.2 refer to power levels at the receiver input and do not include characteristics of the receiving antenna.

The permissible interference levels given in Table 7.2 are based on Recommendation ITU-R SA.1029. They refer to power levels at the receiver input and do not include characteristics of the receiving antenna. The gain of the receiving antenna may be inferred from the values of resolution (km) given in Table 2 of Recommendation ITU-R SA.515 and the knowledge that a typical orbital altitude for spaceborne remote sensors can be taken as 500 km. Note that for spaceborne remote sensing, the sensor antenna is normally directed at the Earth's surface. Note that the levels in Table 7.2 are described as permissible in the context that they meet the interference criteria of passive sensors. However, use of permissible may not necessarily conform with a strict regulatory definition.

ANNEX 8 (INFORMATIVE)

AGREEMENTS FOR ETSI STANDARDS OUTSIDE THE SCOPE OF THIS RECOMMENDATION

1. Systems designed under the assumption of draft EN301166: "Electromagnetic compatibility and Radio Matters (ERM); Land Mobile Service; Technical characteristics and test conditions for radio equipment for analogue and/or digital communication (speech and/or data) and operating on narrowband channels and having an antenna connector".

For these narrow band systems the value of the frequency limit Fa referred in **Figure 2.1**, may be extended to a value not exceeding 250 kHz.

This special case is allowed until 2003. At this date, CEPT and ETSI will review, and if necessary revise, the standard in line with recommends 8 and the CEPT/ETSI MoU before removing the special case.

- 2. The ETSs reported below have fixed masks which were based upon first generation, narrowband techniques and which are now impossible to re-define in the form of variable masks of the table above.
- 2.1 Satellite Earth Stations and Systems (SES); Low data rate Land Mobile satellite Earth Stations (LMES) operating in the 1,5/1,6 GHz frequency bands.

The limits in ETS 300 254, and any TBRs and CTRs based on this ETS, do not have to comply with the limits given in the **Table 3.1**.

2.2 Satellite Earth Stations and Systems (SES); Land Mobile Satellite Earth Stations (LMESs) operating in the 1,5/1,6 GHz bands providing voice and/or data communications.

The limits in ETS 300 423, and any TBRs and CTRs based on this ETS, do not have to comply with the limits given in the **Table 3.1**.

- 3. Until appropriate limits for Mobile Earth Stations above 1 GHz are defined, the limits given in the ETSs reported below should be applied in the relevant bands. It is anticipated that the limits in these ETSs will form the starting point for the development of appropriate limits and in due course these special cases will be removed.
- 3.1 Satellite Earth Stations and Systems (SES); Satellite Personal Communications Networks (S-PCN); Mobile Earth Stations (MESs) including handheld earth stations, for S-PCN in the 1,6/2,4 GHz bands, providing voice and/or data communications under the Mobile Satellite Service (MSS).

The limits in ETS 300 733, and any TBRs and CTRs based on this ETS, do not have to comply with the limits given in the **Table 3.1**.

3.2 Satellite Earth Stations and Systems (SES); Satellite Personal Communications Networks (S-PCN); Mobile Earth Stations (MESs) including handheld earth stations, for S-PCN in the 2.0 GHz bands, providing voice and/or data communications under the Mobile Satellite Service (MSS).

The limits in ETS 300 734, and any TBRs and CTRs based on this ETS, do not have to comply with the limits given in the **Table 3.1**.
