Progress Report since the last TSG (for all involved WGs):

During RAN4#34, 7 contributions on UMTS 900 were discussed. The main topics of the discussion were:

- Deployment scenarios and simulation assumptions

- Proposal for the changes in TS25.104 and TS25.101 for the introduction of 900 MHz band

ECC-PT1 has requested 3GPP to perform sharing studies on three additional deployment scenarios, 3GPP RAN4 has identified more. 3GPP RAN WG4 plans to perform studies on the following scenarios:

- Scenario_1: UMTS(macro)-GSM(macro) in Urban area with cell range of 577 m in uncoordinated operation
- Scenario_2: UMTS(macro)-GSM(macro) in Rural area with cell range of 5000 m in uncoordinated operation
- Scenario_3: UMTS(macro)-GSM(macro) in Rural area with cell range of 5000 m in coordinated operation
- Scenario_4: UMTS(macro)-UMTS(macro) in Rural area with cell range of 5000 m in uncoordinated operation
- Scenario_5: UMTS(macro)-GSM(micro) in Urban area in uncoordinated operation
- Scenario 6: UMTS(macro)-GSM(pico) in Urban area in uncoordinated operation

Considering the number of simulation scenarios and the simulation work load, RAN WG4 agreed to propose the UMTS900 WI new completion date as December 2005, which will be reviewed with the progress of the simulation work.

A TR (TR25.8xx) will be generated to capture the simulation assumptions and simulation results for the planned sharing studies.

The responding LS (R4-050282) agreed at RAN WG4 will be sent to ECC-PT1 by 3GPP RAN after review by RAN plenary.
