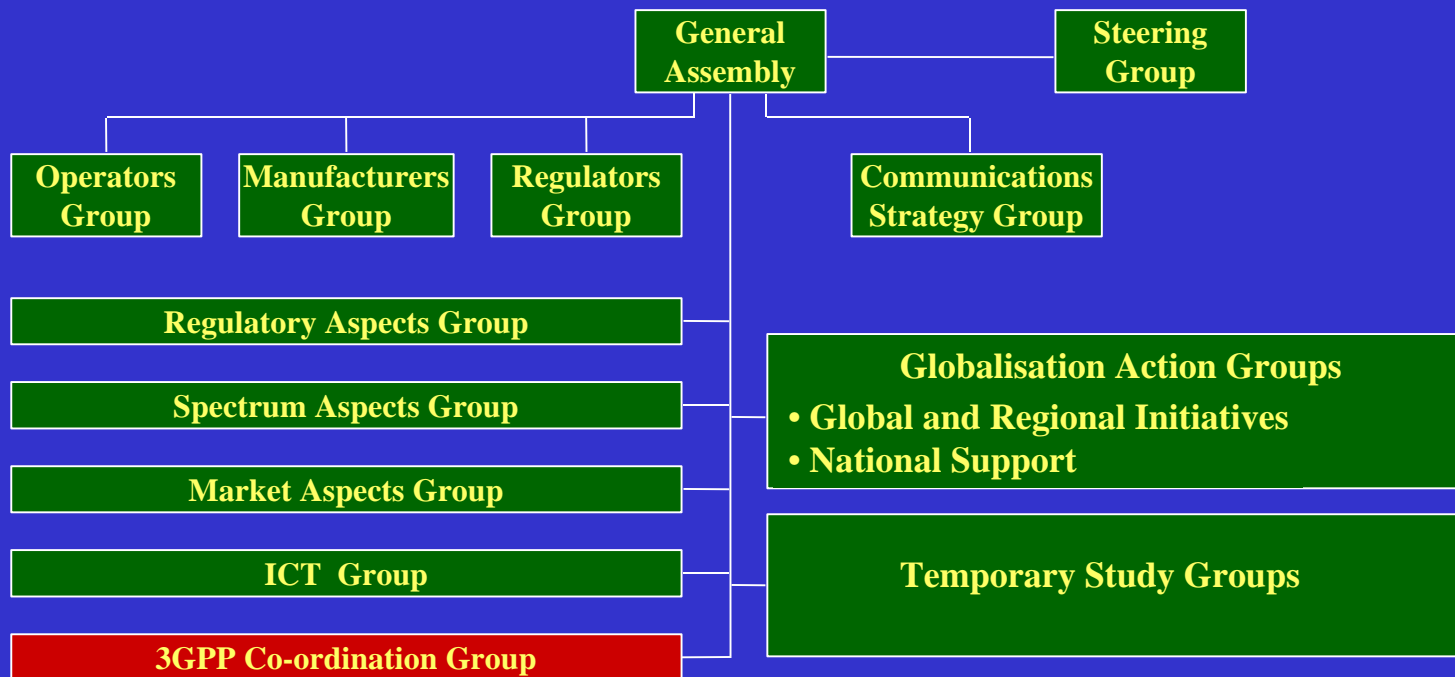

3GPP Co-ordination Group ToR

- **The need for market representation from the Forum is stated in the Terms of reference for the 3GPP: "Standardisation must meet market needs".**
- **In order to facilitate this, the Forum should contribute its expertise in the area of market and business knowledge, spectrum issues, regulatory impact, the Forum's vision and the new knowledge that is being acquired as a result of the dialogue with the IT, multimedia and content business.**



3GPP Co-ordination Group ToR

- **Inputs from the Forum which impact on the technical development in the 3GPP TSG's are likely to be mainly in the services area of the Systems and Services Aspects TSG. These could include the services, capabilities and features to be provided by UMTS in terms of market (etc.) requirements. However, it must be stressed that the Forum was not established to comment on the detailed technical solutions coming from the technical experts in the TSG's.**



3GPP Co-ordination Group ToR

- **The liaison with the 3GPP TSG's and the inputs to it from the Forum should be handled by a UMTS Forum Co-ordination Group specially set up for the purpose. This group should pro-actively seek to put the Forum's market (etc.) expertise into the appropriate TSG's.**
