#### 1. Overall Description:

GSMA SCaG is aware of the CR (SP-030355) on 22.038 approved in 3GPP SA regarding new requirements to support the management of MMS by the UICC applications.

GSMA SCaG has been working on MMS management by the SIM card providing compelling use cases and requirements.

There is a common understanding within SCaG stating that this CR does not completely achieve the goals needed for this new functionality, since the current version of the requirements does not cover the capability of the USIM to provide the MM content to be sent.

As it was discussed in SCaG #25, there is no valuable reason to stop these new features based on arguments like the ME/UICC interface speed, or the available UICC memory, since all of these parameters are constantly progressing and the future availability of larger memories and faster protocols can be considered as a fact.

GSMA SCaG is not completely satisfied with the current status of this work and would like to encourage 3GPP to find the quickest path in order to include all these new features in Release 6 specifications.
