3 Justification

It shall be possible to establish an emergency speech call to the serving network. Emergency calls will be routed to the emergency services in accordance with national regulations. This may be based upon one or more default numbers stored in the ME and/or USIM. It shall be allowed to establish an emergency call without the need to dial a dedicated number to avoid the mis-connection in roaming case, such as menu, or a linkage to a car air bag control. This functionality shall be supported by the UE without a SIM/USIM being present. No other type than Emergency calls shall be accepted without a SIM/USIM.

It shall be possible for the called emergency instance to recall the emergency caller, if the call is interrupted. However, loss of radio contact is out of scope of this requirement. This functionality shall be supported with and without an USIM being present in the UE.
