### **Tdoc N SS-99117**

The agenda in document Tdoc N\_SS-99117 was presented. There was no comment and the agenda was approved.

### Tdoc N SS-99143

A document with a proposed allocation of document to the agenda items.

- New documents: 141 & 143 are documents for information. Agenda item 4.3
- Document 144 is a new document in agenda item 4.3.
- The LS in 122 is withdrawn. The document was sent by mistake from N1.

The agenda allocation was approved.

# Reports from other meetings / general / liaison statements

Steffen reported from other meetings.

### CN plenary in Kyonju:

It was a decision to freeze R97 & R98 and no new features will be included in these releases. CRs are allowed if they are very important corrections or if the corrrection are approved by all the manufactures. Each CR has to have one of three certain categories before it can be approved. A document with these categories will be available at this meeting.

Follow me will be a GSM specification. The specification was presented at a 3GPP Specification due to a decision at a previous meeting. At CN#5 there was a decision to transfer it back to GSM since ASCI is a GSM feature and they would like it to keep this two WI together. Both SS ad hoc and S1 would like to have it as a 3GPP spec.

Two different ad hoc groups were created. ITU ad hoc and OSA/VHE.

Yun Chao Hu and Ian Park are delegates in the ITU ad hoc group. So interested delegates can contact them.

The OSA/VHE ad hoc group was created due to lack of information about the impact for CN in the stage 3. They have had one first meeting and will have the second one in a couple of weeks. The chairman of the meetings is Yun Chao Hu.

### Report from N2A

The N2 meeting has decided what will be a part of Camel phase 3 even though there are some more work with some of the items. There is an editors group meeting in Germany this week that will finalise the CRs of the specifications that will be sent to the plenary.

### **Meeting report**

### Tdoc N\_SS-99118

A draft version of the meeting report was presented in Tdoc N\_SS-99118. The draft version has already been presented at the last CN-plenary meeting. There was no last day for comments but no comments have been received so far.

Decision: The document was approved

### **Liaison Statements**

### Tdoc N\_SS-99119

The document is Liaison statement on 3G-H.324M from the N2. They inform SS ad hoc about a new bearer service that may have impact of the SS. SS ad hoc decided to wait for a decision from S1. <u>Decision</u>: The document was noted.

### Tdoc N SS-99120

An answer from N2 to a LS from SS ad hoc on CCBS interactions with 3G TS 23.012 was presented. SS ad hoc see a need on co-operation with N2 on this issue. Information on the status of 23.012 is required and SS-ad hoc has to inform CN plenary about the impact. The specification will be sent out on E-mail to the SS ad hoc list so it can be discussed at the next meeting.

<u>Decision</u>: The document was noted. For further study.

### Tdoc N\_SS-99122

Withdrawn

### **Tdoc N SS-99123**

The document, a response to a LS on Service/Baseline Implementation Capabilities, from N3 was presented by the chairman. It is sent as a copy to SS ad hoc and no action is needed. Decision: The document was noted.

### **Tdoc N SS-99158**

TSG-T2 SWG6 have received a document with comments from SS ad hoc on a LS on Service/Baseline Implementation Capabilities of the NAS. They thank SS ad hoc for the comments and described the outcome of the comments. SS ad hoc had one comment on the response and that was that the categories should be revised. Steffen will contact the originator of the document.

Decision: The document was noted.

### **GSM Release 97 and 98 supplementary service matters**

### **Tdoc N SS-99145**

For information Steffen presented the liaison to other TSGs, about the CN decision to freeze R97 &98. All changes to R97 & R98 have to be categorised before they will be submitted to CN. Decision: The document was noted.

### **Multiple Subscriber Profile Phase 1**

### Tdoc N SS-99124

Comments on 03.97-A003 (MSP phase 1, Call Deflection & O-CSI apply in Connect). Alcatel points out that the specification defines things that are not needed, the O-CSI applicable parameter. Alcatel will write a CR on this.

Decision: The document was noted.

### Tdoc N\_SS-99125

The document of Interaction between MSP Call Forwarding & GSM Call Forwarding is a contribution from Alcatel. There is a need to of clarification of it for the MSP. The MSP shall not have any CF provisioned in the HLR. Alcatel will write a CR on it.

<u>Decision</u>: The document was noted.

### Tdoc N SS-99152

Patrick presented the CR that covers the issues that were discussed in document Tdoc N\_SS-99124 & Tdoc N\_SS-99125. It will be categorised with Category C3, which means that has to be agreed among the manufactures. A mirrored CR to 23.097 that will have category A will be presented later on by Alcatel.

Decision: The CR was approved.

### Tdoc N\_SS-99159

The mirrored CR to Tdoc N\_SS-99152 was presented and approved.

Decision: The CR was approved.

# Release 99 supplementary service matters

The chairman informed the delegates that Release 99 has to be finalised during this week. Next year it will not be possible to add new features in R99 just add changes to features that are already a part of R99. In the end of the meeting SS ad hoc has to have a clear view on what is possible to have in R99 and what has to be handed over to release 2000

### Multiple Subscriber Profile, Phase 2

### Tdoc N SS-99127

Ruth presented a CR to 23.072-002r1 on Inclusion of the handling of the Service Interaction Indicators Two parameter from Vodafone Airtouch. The CR was presented at the last meeting. The only thing that has been changed in the CR since the last meeting is the procedure name.

Decision: The CR was approved

### **Tdoc N SS-99128**

CR 23.083-001r1 on Inclusion of the handling of the SII2 parameters from Vodafone Airtouch was presented. The only thing that has been changed since the last meeting is the Company name on the coversheet.

Decision: The CR was approved.

### Tdoc N SS-99129

Ruth presented the CR 23.084-001 on Inclusion of the handling of the SII2 parameters from Vodafone Airtouch. The coversheet is the only thing that has been changed since the last meeting..

Decision: The CR was approved.

### Tdoc N SS-99130

The CR 23.091-001 on Inclusion of the handling of the SII2 parameters was presented. The coversheet has been changed since the last meeting.

Decision: The CR was approved.

### Tdoc N SS-99131

The CR 23.093-001r1 on Inclusion of the handling of the SII2 parameters has been changed since the last meeting due to an alignment to a decision at the CAMEL meeting. Names and values SII2 parameter has been changed.

Decision: Revised in document Tdoc N\_SS-99153

### Tdoc N\_SS-99153

Ruth presented the Revised Version of Tdoc  $N_SS-99131$ . The only change that has been done in this document since it was presented last time is the alignment of the name. One word is still missing and will therefore be revised in document Tdoc  $N_SS-99155$ .

Decision: Revised in document Tdoc N\_SS-99155.

### Tdoc N SS-99155

The Revised Version of Tdoc N\_SS-99155 was presented and approved

<u>Decision</u>: The document was approved.

### $Tdoc\ N\_SS\text{-}99132$

A CR on Addition of CCBS to the SS Invocation Notification to 23.093 was presented at the last meeting in Sophia but since someone came up with a much better solution it has been revised. The CR has been updated in that way: MSP Phase 2 requires CCBS recalls to be charged to the correct profile, hence notification of CCBS invocation is required. SS notification's hooks should be described in the CR. The document will be revised in Tdoc N SS-99154.

Decision: Will be revised in document Tdoc N\_SS-99154

### Tdoc N\_SS-99126

Ruth presented the CR 23.097-002 on MSP. There are still some works to be done and therefore new CRs on this topic will be presented at other meetings.

Decision: The CR is approved.

### Follow Me (GSM 03.94/04.94)

### **Tdoc N SS-99134**

The contribution is a proposal for handling of interaction Follow Me with CFU from Siemens. Faqiang presented the document. At the last meeting in Sophia Antipolis there was a proposal to change the CFU processes due to introduction of FM. The CFU and the FM are two different services and it is interactions between them. For safety reason the FM registrations is not allowed to override. The proposal is, if FM is registered as active, CFU will automatically be registered as active but not vice verse. If registration of FM has been done, the result of interrogation of CFU will give the result of FM. The CFU is needed to forward the FM call. Since the CFU shall not be changed from the subscriber's point of view the proposal was not agreed. There was a proposal to introduce a FM controller that will take care of the co-ordination between the FM and CFU. With this there is not need to change 03.82. Faqiang will start to edit the SDLs in the specification tonight. An explanation has to be included in the specification and the labels are missing in the document 03.82. Decision: The document was rejected.

# Tdoc N\_SS-99135

Due to the decision of Tdoc N\_SS-99134 the Tdoc N\_SS-99135 was not relevant.

Decision: The document was withdrawn

### Tdoc N SS-99136

SS ad hoc asked about Service code10 but in the spec 25 is defined but there hasn't been confirmed in a written format. Ruth will contact Alan Cox and ask about it.

Comments on the contribution was:

- SI in figure 4.1 note 2 shall be changed from Supplementary Information to AI, additional information.
- The interaction with CFU is missing.
- Some editorial comments in annex A from Vodafone.

Decision: Revised Version will be presented tomorrow in document Tdoc N\_SS-99149

### Tdoc N\_SS-99137

Faqiang presented a proposal to introduce Forced Erasure in the stage 2 specification. A CR to FM Spec Stage1 (02.94) in respect of Forced Erasure by supervisor has been submitted to the SA1 and will be handled this week. If it will be accepted by the SA1, then a solution should be worked out in stage 2. Vodafone commented that there are just two days left to finalise R99 the FM specification has to be stable. Option B in the contribution is the only one that can be provided for R99 and preferred one.

In the end of the week Celine informed that S1 agreed to include Forced Erasure in stage 1. Decision: The option is the preferred one.

### Tdoc N\_SS-99138

Since S1 has decided to include the Force Erasure in stage 1. Faqiang presented Siemens proposed changes in the Stage 2 specification to include the Forced Erasure by supervisor. The SDL still has to be updated. A new version 1.3.0 which will include the proposed changes shall be sent out on E-mail to the SS ad hoc list on Tuesday and last day for comments is Thursday If it's agreed on Thursday it will be sent to the plenary on Friday morning. Otherwise the version 1.2.0 will be sent to CN#6.

Decision: The principle is agreed but further work has to be done. SS ad hoc has to wait for a decision from the S1.

### Tdoc N\_SS-99149

Faqiang Revised Version of the Follow me stage 2 specification. Comments: Same name for the same procedures. The general comment

<u>Decision</u> The document will be revised in Tdoc N\_SS-99157.

### Tdoc N\_SS-99157

The Revised Version Tdoc N\_SS-99149 was agreed and will be sent to CN plenary. <u>Decision:</u> The document was approved.

### Tdoc N\_SS-99160

Celine presented proposed LS from Nortel to have Follow me as a 3GPP specification. SS ad hoc has already sent a LS to an earlier CN plenary saying that they recommend them to have it as a 3GPP specification, not a GSM specification. SS ad hoc delegates are still convinced that they would like to have it as a 3GPP specification and the chairman will highlight it in the plenary.

Decision: The document was rejected.

Celine presented the CR to 02.94 on Introduction of the role of a "Follow Me service supervisor" that was agreed at the S1 meeting, this week for information.

Decision: The document was noted.

### USSD Enhancements (GSM 03.90/04.90)

### **Tdoc N SS-99144**

Tdoc N\_SS-99161

Regis presented the CR 23.090-001 on USSD enhancement from France Telecom. The delegates are asked to check the SDLs. Ruth and Regis will at an ad hoc meeting check the SDLs and if there is a need of editorial changes.

<u>Decision</u>: The document will be revised in document Tdoc N\_SS-99148.

### **Tdoc N SS-99148**

The revised version of Tdoc N\_SS-99144 was presented and approved.

Decision: The document was approved

### Tdoc N\_SS-99141 & Tdoc N\_SS-99142

Celine presented the two CRs of 23.002 that was approved in the N2 meeting in Phoenix two weeks ago, for information. The work items of these CR are Follow me and USSD.

Decision: The document was noted.

### Call Forwarding Enhancements (GSM 03.82/04.82)

### Tdoc N\_SS-99133

Ruth presented the CR 23.082-002 from Vodafone on Inclusion of the handling of Long Forwarded-to Numbers. Has to present, longer than 15 digits, the supported entity shall use the long forwarded to number instead of forwarded to number. A LS to S1 explaining what they get. Ruth will prepare the LS in document td-146.

Open issues new ss version of ss operation. SS version indicator is needed. Postponed and SS ad hoc would like to have it in R99 even though further work is needed.

Call deflection is not included. This will be highlighted in the LS to S1.

Is it supported in CAMEL

<u>Decision:</u> Several open issues and the item will be discussed later.

### Other Release 99 Work Items with impact on supplementary services

### **Location Services**

### **Tdoc N SS-99139**

Raja presented document from T1P1 on LCS. The document contains several documents but T1P1 ask SS ad hoc about endorsement of a CR 04.30 and approval CR 04.80-A060.

SS ad hoc see a need of more detailed information is for the 04.30.

- The parameters send should be named. .
- Who will take care of the spec?
- Is it a supplementary service?

The new specification was endorsed by ss ad hoc at technical viewpoint but is not a SS ad hoc specification

For CR 04.80-A060 SS ad hoc noted that there is no background information is provided. It will probably be described in the 03.71 specification.

- Spelling corrections is needed.
- A mirrored CR is needed

CN has an agreement with SMG to approve this for R98. In C#5 agreed to freeze the R98 and therefore SS ad hoc will ask the CN plenary of advice. Steffen and Raja will draft the LS. Decision: A LS to CN will be provided in Tdoc N SS-99147 asking about advice.

### **Tdoc N SS-99121**

A liaison from N2 addressed SS ad hoc, S1 and N1 was presented. N2 point out that stage 1 defines multicall as a basic service even though it defines service control procedures. SS ad hoc view is that multicall is not a basic service. It might be either network feature or Supplementary service. Steffen will draft a LS to S1 that will be presented on Thursday.

Decision: The document was noted.

### Tdoc N\_SS-99140

Lisa presented a CR from Ericsson on Alignment with the CW description for Multicall in the 23.083-002. The conditions are described in the stage 1 specification not in stage 3 and therefore there is a need of a reference to the stage 1. Maximum number of calls is not defined in the stage 1 specification. The status of the specification was not known and the latest version will therefore be available later in this meeting. The delegates are also asked to collect more information from S1 and N2.

After the discussion of Tdoc  $N_SS-99150$  and Tdoc  $N_SS-99151$  the CR was rejected. <u>Decision</u>: The CR was rejected.

### Tdoc N\_SS-99150

The stage 1 specification was presented for information.

Comments and open issues in stage 1:

- Bearer and calls are mixed up
- If there are 7 ongoing transactions CW can't be executed.
- Interaction with other supplementary services.

Steffen will draft a LS, addressed CN highlighting that there are many open issues. Multicall has been on the agenda at several SS ad hoc meetings but just a few contributions have been submitted. Therefore SS ad hoc recommends that it will not be included in R99. The LS will be presented in Tdoc

Decision: The document is noted.

### Tdoc N SS-99151

N SS-99156.

The CR 22.0823-002 on multicall has been sent for information to the meeting. SS ad hoc doesn't see why this CR has been submitted and the status of it. If it has been agreed at SA, it sounds strange that they agree on such a CR.
