Opening of the meeting and approval of the agenda

Frans Haerens welcomed the newcomers that arrived for the joint meeting SPAN 3 and N2A. He thanked the Eircom that hosted the meeting and informed about the meeting arrangements. Steffen Haberman will chair the joint meeting that will take place the 20-21 of october where the CAMEL discussion will take place. This afternoon and tomorrow a parallel meeting handling API will take place.

The meeting has to close down early today and everyone is invited to the social event that will take place this evening.

Next joint meeting will be in Phoenix, Arizona the 17-18 November. The joint meeting will be two days but the N2 meeting will take place during the whole week. Since it is a long trip for the SPAN3 delegates Frans recommended them to stay at the N2 meeting as well.

Steffen informed the meeting that the CN plenary has agreed on splitting the CAMEL phase 3 into to releases. Since it's just one meeting left until the Release 99 should be finalized N2A will focus on R99 issues during these two days.

There was no report for VOIP available at this meeting but Michel informed that it would be a final version at next meeting. Michele will work on it and if anyone has something to add to this please contact him.

Tdoc N2-99D51 (Agenda)

Steffen presented a proposed agenda in document Tdoc N2-99D51.

Proposed Changes: Release 97 NTT proposed to move the document Tdoc N2-99E57 to Release 97.

Charging issues

Nokia proposed to move the Tdoc N2-99E23 &Tdoc N2-99E25 to the charging issues.

Dialled Services

At agenda item 4.1 T-mobil would like to add the document Tdoc N2-99E91. Siemens will also provide the meeting with a document regarding the same topics.

Decision: The agenda was approved with the proposed changes.

CAMEL Phase 2 Release 97

Tdoc N2-99D59

Sumio presented a CR to document 03.78 on the document of gsmSSF Correction for FCI. In Abiko N2 proposed to freeze the R97 & R98 for CAMEL. CR:s of certain categories will always be possible to agree on. Steffen informed the meeting that the proposal has been presented and revised in CN and it will be available during this meeting (Tdoc .N2-99F03). Decision: The CR is rejected.

Other business

Rogier had a question about what will happen if a CR is implemented in the wrong way. Should the specification be updated or should a new CR be prepared. One example is 03.78 A105 that was not corrected implemented in the specification. Then the specification was updated to 6.4.1. After publishing of a new version a new CR has to be produced if one CR has been wrong implemented.

The CR:s that shall be sent to. Phoenix shall be based on version 6.5.0

CAMEL Phase 3 Release 99

MSP

Tdoc N2-99D53

Ruth from Vodafone presented the document N2-99D53 a CR of SS ad hoc for CAMEL Phase 3.

If MSP should be a part of Release 99 or Release 2000 dependents on T-BCSM in VMSC which is not in the Release 99 at the moment. The discussion will be postponed until the status of the T-BCSM is clear. MSP and T-BCM in VMSC will be handled together and to which release they should be a part of has to be after this two days. Sumio said that there are short of time and pointed out that just the issues that will be in R99 shall be discussed. MSP was moved to Agenda item 4 and the issue will be discussed after that R99 have been handled.

Ruth presented the CR:s of MSP for information. They will be represented in the Phoenix meeting when the whole package has been finalized. She asked about comments as before next meeting. Otherwise the contribution will be presented again for approval in the same way at the next meeting. Decision: The document was noted.

Tdoc N2-99D55.

The contribution from Vodafone was split into several CR:s. Decision: Withdrawn

Tdoc N2-99E65

Ruth presented the CR for 23.008 on Addition of CCBS to the SS Invocation Notification for information. Decision: The document was noted.

Tdoc N2-99E67

Ruth presented the CR 23.002-041r1 on Addition of CCBS to the SS Invocation Notification for information. Decision: The document was noted.

Tdoc N2-99E81

Ruth presented the CR 23.018-005r1 on Inclusion of handling of the Service Interaction Indicators Two parameter, for information. Decision: The document needs to be revised.

Tdoc N2-99E83

Ruth presented the CR for 23.078 on Inclusion of the handling of the Service Interaction Indicators Two parameter for information. Decision: The document has to be checked.

Tdoc N2-99E85

Ruth presented the CR for 29.078 on Inclusion of CAMEL CUG handling for information. Decision: The document was noted.

Tdoc N2-99E69

Ruth presented the document of CLIR provisioning per profile for an MSP Subscriber. It was concerns about regulations but so far there are no other solution Some delegates support it and other is against The issue has been discussed several times in SPAN before is possible to discuss it with span tomorrow. The item has to be studied further. There will be a liaison statement presented at the next N2 plenary meeting. Decision: The document was noted.

Tdoc N2-99E95

Ruth presented the CR for 23.078 on Inclusion of the handling of the Service Interaction Indicators Two parameter for information. Decision: The document was noted

Ruth presented the CR for 23.078 on Addition of CCBS to the SS Invocation Notification for information. Decision: The document was noted

Tdoc N2-99E99

Ruth presented the CR for 23.078 on Inclusion of CUG handling for information. Decision: The document was noted.

GPRS

Tdoc N2-99D57

Sumio presented Stanislav's contribution to 23.078 and 23.016 on CAMEL Capability Handling for GPRS. There was some comments on it:

- Corresponding table shall be implemented in chapter 6.6.3
- A note shall be added to the table that clarifies if camel phase three is allowed.

Decision: The contribution was accepted with modifications and Sumio will put it in the draft spec.

Tdoc N2-99E03

Sumio presented another of Stanislav's contribution for decision on GPRS. The title of the document is "Clarification of GPRS TDP Handling". For GPRS there is one relationship to gsmSCF for Attach / Detach FSM and one relationship to gsmSCF per PDP context for PDP Context FSM. The intention with the contribution is to specify them.

The comments was:

- A corresponding SDL:s are missing.
- Remain the EDP-R.
- Rogier and sumio will together change the note in the PDP context. Perhaps it will be a separate paragraph
- Christian and Rogier will draft a text for the contribution

Decision: Siemens will revise the document in document N2-99F01.

Tdoc N2-99E43

Sumio presented a proposal from Siemens about TCAP Handling for GPRS-CAMEL Interworking. The meeting asked about further information. The usage of TCAP resources has to be studied more. Decision: The document was noted.

Tdoc N2-99E73

Pierre presented the Alcatel contribution about Interworking GPRS with CAMEL phase3. They proposed a new approach for GPRS support by CAMEL. The meeting realized that there is a problem and there are several ways to solve it. This issue has to be studied further. Decision: The document was noted

Mobility managent

Tdoc N2-99D61

Rogier presented the document Tdoc N2-99D61 of mobility management Introduction of Mobility Management event notifications in 09.02. The document is a revision of document N2-99B00, which was presented in Abiko and has already been presented at the N2B meeting Eton. The document will be revised once more and will then also contain the comments from N2B. Rogier will make the new document available for tomorrow.

Decision: The document was noted and a will be revised by N2B in document Tdoc N2-99F66

Tdoc N2-99D63

The contribution from Ericsson introduces the processes for Mobility Management event notifications in specification 29.002. This document has already been presented in Eton. Decision: The document was noted.

This contribution specifies the interworking between GSM Location Management processes and the CAMEL Mobility Management process. The document was presented in Eton yesterday. N2B had a few minor remarks to it. The contribution will be revised and implemented in the 29.002. Later on this part will be deleted in this document and put into 23.012.

Decision: New revision of the document.

Tdoc N2-99E79

Mobility Management Triggers for Insert Subscriber Data in specification 23.078 was a contribution from Alcatel. Ericsson presented a contribution to the same item in document TDoc N2-99C05 in Abiko and this document is a proposal to improve it.

Decision: The contribution was accepted.

SMS

Tdoc N2-99D89

Iris from Sonera presented the their proposal to include some Enhancement of Initial DP SMS in spec 23.078. This topic was also discussed in Abiko .S1 has had an Ad hoc meeting since then and they have decided to include this in the CAMEL phase 3 stage 1.

Decision: Agreed with the minor changes. Sonera and Siemens will discuss it together and put it in the draft specification.

Tdoc N2-99D91

The contribution is compiled on the contribution N2-99A78 'CAMEL3 MO SMS modifications to 29.078' which was agreed in Abiko to be included in the draft spec. However, such a draft version was not yet available.

Decision: The contribution was agreed and it will be incorporated in specification 29.078.

Tdoc N2-99E17

Keijo presented the CR to 23.078 on Further CAMEL3 MO SMS modifications to 23.078. No serious technical changes and simular to the ciscuit switched handling. The suggested changes was:

- Some operation names have been changed. The new names are "xxxx SMS".
- SA1 CAMEL adHoc approved that MO SMS failure and submission shall be EDP-Rs as well. Tdoc S1-99689 by Ericsson.
- Appending mechanism of FCI is introduced in this CR. See sections 7.6.2.4. and Figure 68e.
- FCI handling is aligned with the call cases, i.e. procedure name "Complete_SMS_FCI_Record".
- Map operation UpdateLocation and UpdateGPRSLocation contain CAMEL information; However, they were not described in the 3G TS 23.078.
- It was seen useful to combine MSC and SGSN sections for MO SMS. Therefore sections 7.6.3 and 7.6.4. are removed and sections 7.6.1 and 7.6.2. cover gprsSSF as well.

There were some comments about the contribution:

- Restore data will be checked by Rogier
- The Procedure CAMEL_O_SMS_INIT will be discussed off line.
- Does the charging mechanism have impact on the SMS.?
- Generic handling. Shall it be applicable for SMS as well?

Decision: The document will be revised in document Tdoc N2-99E93

Tdoc N2-99E93

Keijo presented the revised contribution on further CAMEL 3 MO SMS. The document was agreed accept for the "Append Free format data" in the table of information element that shall be revised by the editors. Decision: The document was partly agreed.

The contribution is a modification to 29.078 on CAMEL3 MO SMS from Nokia.

The present contribution addresses the following issues:

- Some operation names have been changed. The new names are "xxxx SMS".
- SA1 CAMEL adHoc approved that MO SMS failure and submission shall be EDP-Rs as well. Tdoc S1-99689 by Ericsson.
- Appending mechanism of FCI is introduced in this CR.
- It is clarified that ReleaseSMS and ConnectSMS are not allowed operations in O_SMS_Submitted nor O_SMS_Failure EDPs. These DPs are EDPs just to allow better charging interworking with the FCI-SMS operation. See sections 9.12.3.1 and 9.kk.3.1.

Comments on the contribution were:

- Check the stage 2 if it's mandatory or optional.
- Correction of Spelling like to Overwight to override.

Decision: The contribution was accepted with editorial modifications.

Tdoc N2-99E39

Sumio presented the contribution of SMS, New Operations for SMS in 29.078. The contribution was accepted. The changes has been for circuit switched but that was suggested that it also will applicable to GPRS

Decision: The contribution was accepted.

SoLSA

Tdoc N2-99E13

Keijo presented the CR to 23.018 on CAMEL3 SoLSA interworking with MT calls & ATI. SoLSA interworking is added for AnyTimeInterrogation and for MT calls. In MT calls selected LSAid is sent to GMSC over MAP.Isabelle had some concerns about it's a BSS issue as well and they would like to contact BSS people before. Keijo will prepare a contribution that will be sent too the SA1 so that the stage 1 specification will be updated.

Decision: The contribution was accepted.

Tdoc N2-99E15

Keijo presented the corresponding CR to 23.078. Decision: The contribution was accepted with minor modifications.

Tdoc N2-99E21

Nokia presented a contribution of CAMEL3 MO SMS, GPRS and SoLSA modifications to 29.002. CAMEL inter working with SMS is added and the required changes for CAMEL GPRS and SoLSA changes are incorporated. The first document contains changes to CAMEL phase 3 and GPRS into the MAP specification.

The document was presented at the Eton meeting. Rogier participated at the meeting and summarized the outcome of the discussion. The contribution was accepted with minor changes. Probably a Revised Version will be presented at the next meeting.

Decision: The document was noted.

Charging

Tdoc N2-99E27

The document is a reply from SA5 to a LS about further information about the free format charging data A LS was sent from N2 to WG5 and this document is a reply to this LS. Keijo presented this documents since he was the one that wrote the LS in the beginning.

The content of the FCI data was discussed and it has been agreed that not all the fields will be used. Since SA5 didn't give any guidelines N2 has to make up an assumption. Total amount of data is an open issue and the maximum amount has to be defined now. The meeting decided a starting point of 160 octets. If any other has another opinion the they shall come back with it at the Phoenix. SA5 has to be informed at a later state

The document was also sent to S1 but was not on the agenda at the last S1 meeting!

Decision: The document was noted.

Tdoc N2-99E49

Rogier presented the CR to the specification of 23.078.

The present contribution addresses the following issues:

- increase of free-format data in the FCI message, from 40 to 80 octets
- introduction of the append mechanism for the FCI message

Decision: The content was agreed in principle but since there are some modifications that has to be done, therefore the editors has to discuss it further together with the editor of the proposal.

Tdoc N2-99E51

Rogier presented the corresponding Cr to Tdoc N2-99E51. The contribution describes only the changes to FCI for circuit switched calls.

Decision: Accepted with minor changes. Will be incorporated in the draft specification 29.078.

Tdoc N2-99E23

Keijo presented the document on 23.078 CAMEL3 Warning Tone improvement. Enhancement on the existing CAMEL phase 2. This item was presented for phase 2 but it was too late to incorporate. Now the proposal is represented but for CAMEL phase 3. Decision: The contribution was accented

Decision: The contribution was accepted.

Tdoc N2-99E25

The contribution is a CR to 29.078 CAMEL3 on Warning Tone improvement from Nokia. Decision The contribution was accepted and will be put into the draft specification.

Location Services

Tdoc N2-99E41

Rogier presented the contribution from Ericsson onStage 3 in CAMEL location services. The document is a CR to 29.002 and it specifies the GMLC as recipient for the Any Time Interrogation message. The document was presented in the meeting in Eton, yesterday. The specification belongs to N2B. Decision: The document was endorsed. Further handling will take place in N2B

Other Stage 2 issues

Tdoc N2-99D81

Sumio presented the document from Siemens. To allow more flexibility, in OR scenarios operating pre-paid solution, Siemens proposed SCI modifications.:Alcatel had the commented that this contribution is not necessary.

Decision: Postponed until tomorrow.

Alcatel presented a contribution about Called Party Number Modification Check in CAMEL. The concept is supported but there are still some parts that is not clear so the discussion will be postponed.

Handling of the triggering in GMSC is not finalized. It was discussed in Abiko but it has to be deled again. The discussion about the numbering check will continue on E-mail. In GPRS and SMS we have the same situation so therefore the discussion will continue later.

Decision: The document will be postponed until someone starts an e-mail debate on it.

Tdoc N2-99E57

Kazuhiko presented a Discussion document on outstanding request counter from NTT The contribution intends to clarify the unit of outstanding request counter. The contribution also handled the impact to the current draft specification.

Decision: The document was noted.

Tdoc N2-99E89

Siemens presented a proposal for Resumption Counter Handling. The document N2-99E89 solves the problem raised in the document N2-99E57. The meeting first agreed to put it into the stage 2 specification but since there is need of changes in the SDL and no one volunteered, the document was just noted. Decision: The document was noted.

TS 23.008

Tdoc N2-99D95

Siemens presented a contribution on CAMEL Capability Handling for CAMEL ph3. There were some comments on it. Sumio will rewrite the document including the comments. Decision: A Revised Version will be presented at the next meeting.

Tdoc N2-99E35

NEC presented the CR 23.008-007 on modification to description of CAMEL subscriber information. The meeting noticed that's there are already other changes in the some way. Decision: The content included in the contribution Tdoc N2-99E35 will be implemented in the draft specification.

Tdoc N2-99E75

Alcatel presented a combined CR to 03. 08 that includes:

- CAMEL phase3 requirements for O-CSI and T-CSI
- introduction of the VT-CSI in the VLR
- improvements on the M-CSI (N2-99C06)

There was a question of the cause value criteria for no answer DP.

Decision: A Revised Version will be presented at the next meeting.

TS 23.016

Tdoc N2-99D75

Superseded by Tdoc N2-99D87

Tdoc N2-99D87

Siemens presented the contribution on a CR to 23.16. Following items are added:

- Short Message Service CSI (SMS-CSI) for CAMEL control of MO SMS, initiated in the VMSC or in the SGSN;
- Mobility Management Triggers
- GPRS CSI TIF csi shall be added.

The comment was that the corrections of TIF csi and the SS-CSI also has to be incorporated in the R97and R98, for the group definitions. No updated version will be presented, the content will be incorporated in the draft specification.

Decision: The document was agreed with some modifications.

Sumio presented the contribution of Clarification of GPRS CSI in 23.016. One remark was that GPRS is missing in document 23.008. Decision: The document was noted.

Draft Specifications

Tdoc N2-99D71

The draft specification of CAMEL Phase 3 - Stage 2 in document 23.078 was presented. The delegates was asked to checked if all their CR:s are correct implemented. If it's wrong implemented please contact the editors before next meeting. Decision: The document was noted.

Tdoc N2-99E87

Jörgen presented the draft CAMEL Application Part (CAP) specification 29.078. Decision: The document was noted.

Tdoc N2-99E31

NEC presented a contribution of Clarification of EventTypeBCSM and RequestReportBCSMEvent in CAMEL Phase3. Decision: The content will be incorporated in the draft specification 29.078.

Tdoc N2-99E37

Ericsson presented a CR on 29.002 on Indication of supported CAMEL Phases. The purpose of this contribution is that all the nodes shall clearly indicate which CAMEL phases are supported. Decision: The document was endorsed. Further handling will be in N2B.

CAMEL phase 3, Status to be determined

Sumio presented the document for decision about the CSI Modification for NCSD. They propose to enhance the O-CSI structure. Decision: The document was noted.

Sumio presented the next contribution of Dialled services for discussion and decision. The document showed the amount of O-CSI data that has to be transferred after that the introduction of DP Anaylsed Info. Decision: The document was noted.

Tdoc N2-99E01

The contribution of Clarification of Unsuccessful TDPs was a contribution from Siemens presened by Sumio. In CAMEL ph3 there are 3 TDPs defined for O-BCSM and 3 TDPc for T-BCSM. In Tdoc S1-99770 clarifications regarding handling of the new TDPs were agreed. The contribution suggest that notes about this shall be added in the table of Description of O-BCSM DPs in the MSC & Description of T-BCSM DPs in the GMSC / VMSC in document.
