1 Overview

OMA DM thanks 3GPP TSG-CT6 for their response on separation of duties in the creation of management objects and wishes to make some further clarifications.

2 Proposal

DM would like to clarify the following items:

- A. Definition of data to be provisioned is outside the realm of DM expertise, and is best done in groups with the appropriate expertise. E.g. 3GPP-CN1 for IMS parameters, or OMA LOC for Location parameters.
- B. DM can provide expertise in the creation of the format for containing the data defined in item A. E.g. the creation of new Management Objects (MO) or Application Characteristics (AC).
- C. DM can also provide expertise in the specifying of transports for the formats defined in item B such that overlapping data will not cause future interoperability problems.

3 Requested Action(s)

DM requests careful consideration in the provisioning of 3GPP devices via smartcards, factory provisioning, and OTA. There are possibilities of overlapping data when using multiple transports and formats that can cause interoperability problems.

OMA DM and OMA CP enablers are well proven provisioning enablers, and in order to reduce the complexity of terminal provisioning, DM requests the use of OMA DM and/or OMA CP enablers as the basis for future 3GPP provisioning.
