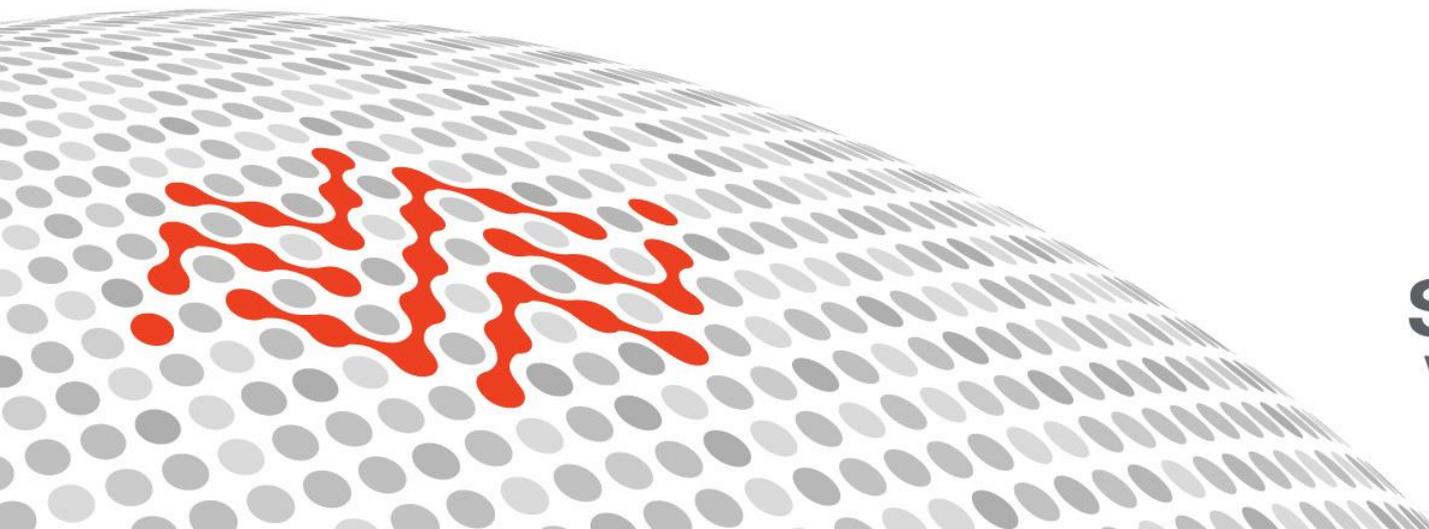




# General Information – GERAN WG3 Numbers


- Participation

- 12 companies/organisations (13 delegates) took part in this Meeting (representing MS and TE vendors - no Test Labs, no Operator)
- 43 CRs were agreed out of 66 CRs (most revisions were editorial as part of the discussions are handled using draft CR prior to the meeting)

- Agreed CRs Spec/WI distribution



- Agreed CRs for the last 3 meetings per meeting



- Only one Incoming LS (from GERAN WG1) was received (on Blocking and spurious response)
- Two Outgoing LSs were drafted to inform GCF CAG, PTCRB or PVG on the progress made during the meeting

# Work Progress – Maintenance

- **GPRS only devices**
  - Applicability modification in TS51.010-2 with the use of a new “exclusion” parameter ([GP-140089](#))
    - Backward compatibility is maintained with previous work but a small harmonization is expected to be done when time permits
  - Overall status of the task:
    - **Considered as Completed**. Omissions or mistakes would be treated as pure maintenance work
- **Miscellaneous updates or correction to other existing TCs:**
  - Rel-10 Feature on RACH power reduction tests were added but might need further enhancements ([GP-140011](#) / [GP-140076](#))
  - A PICS cleaning was done on erroneous PICS/PIXIT. The goal behind that is to have «machine» readable PICS/PIXIT tables
  - UICC/USIM is now officially a possible option for TS 51.010 TCs ([GP-140077](#)/[GP-140078](#))

# Work Progress – Active WIs (1)

- **Test part: Downlink Multi Carrier GERAN**

- A Work plan with the analysis of the core specifications was studied ([GP-140008](#))
- 25 TCs identified (including 2 RF TCs), some of them are based on existing DLDC TCs
- Target completion date is GERAN#63. WID approved at GERAN#55 ([GP-120930](#)) Rapporteur Ericsson

**Overall Status of Completion: 15%**

- **MSRD for VAMOS - MS Conformance Test**

- 5 CRs were agreed (plus one other modification included in an other topic CRs), modifying the existing VAMOS (I and II) TCs
- Work done between last meeting over Telcos and private discussions. TC frame is considered as final but missing limits values (BER requirements, output level, ...) are expected from GERAN WG1 to consider the task as over. Without values the tests are useless.
- Target completion date has not changed yet: GERAN#63. WID approved at GERAN#57 ([GP-130289](#)) Rapporteur: NSN

**Overall Status of Completion: 75% (missing limits values only)**

# Work Progress – Active WIs (2)

---

- **Testing part of Introduction of ER-GSM band for GSM-R**

- 10 CRs were agreed to add the ER-GSM band usage in TS 51.010. No new TC was added, only the TC already dealing with the R-GSM Band had to be updated. The classmark checking TC was of course also updated.
- Target completion date was GERAN#61. WID approved at GERAN#57 ([GP-130889](#)) Rapporteur Kapsch Carriercom & Sierra Wireless

**Overall Status of Completion: 100%**

- **Test part: Support for BeiDou Navigation Satellite System (BDS) for LCS in GERAN3**

- Not started yet. Awaiting core spec completion.
- Target completion date is GERAN#63. WID approved at GERAN#61 ([GP-140097](#)) Rapporteur CATR

**Overall Status of Completion: 0%**


