


E-Meeting Report - Plenary Presentation



# General Information – GERAN WG3 Numbers

- Participation

- 9 companies/organisations took part in this e-Meeting (representing MS, TE vendors and Test Lab, no Operator)
- Out of 63 CRs, 59 was agreed.
  - Agreed (+endorsed) CRs Spec/WI distribution



- 1 Incoming Liaison Statement was seen during the meeting.

# Work Progress – Active WIs (1)

- **Test part: Downlink Multi Carrier GERAN**
  - Second set of TCs drafted (11 TCs based on DLDC TCs).
  - Work plan with the analysis and the remaining tasks ([GP-140788](#))
  - Still 8 TCs identified, some of them are based on existing DLDC TCs
  - Target completion date is GERAN#65. WID approved at GERAN#55 ([GP-120930](#)) Rapporteur Ericsson

**Overall Status of Completion: 80%**

- **MSRD for VAMOS - MS Conformance Test**

- Final CR agreed ([GP-140760](#)), no more mismatch with TS 45.005
- Feature fully covered and could be included in the Rel-12 scope. WID approved at GERAN#57 ([GP-130289](#)) Rapporteur: Nokia Networks

**Overall Status of Completion: 100%**

# Work Progress – Active WIs (2)

- **Test part: Support for BeiDou Navigation Satellite System (BDS) for LCS in GERAN3**
  - More than 30 CRs were studied. The signalling cases were all agreed and are in line with the work done at RAN5 level.
  - Work plan with the analysis ([GP-140797](#))
  - For the minimum performance cases, the scenarios and data files agreement are pending their review at RAN5 level and will be provided for GERAN during next e-meeting.
  - Target completion date is moved to GERAN#65. WID approved at GERAN#61 ([GP-140097](#)) Rapporteur CATR

**Overall Status of Completion: 80%**

# Work Progress – Maintenance

---

- **Miscellaneous updates or correction to other existing TCs:**
  - Numerous updates on NIMTC Tcs showing that they are now being implemented on Test systems
  - Editorial CRs on all TS 51.010 in order to align the latest releases used in every TS.

- **GCF Test Case Optimization**
  - As presented in [GP-140518](#), the GCF technical group has started a task to reduce the number of TC to be executed in order to go through their Certification process. An LS from GCF CAG ([GP-140801](#)) sent to RAN5 and copied to GERAN3 seeking for technical expertise was noted.
  - GERAN WG3 experts will try to provide inputs during their next e-meeting.
