**Title:** Liaison statement on Transfer of Specifications to 3GPP

SMG1/S1 is about to finalise it's work to transfer and update all of the 02-series specifications to the 22-series and to make them suitable for 3GPP (i.e. both GSM and UMTS).

To complete the work S1 has produced CR's to update:

**TS 02.01** "Principles of telecommunication services supported by a Public Land Mobile Network (PLMN)" is transferred to **TS 22.001**.

**TS 02.03** "Teleservices supported by a Public Land Mobile Network (PLMN)" is transferred to **TS 22.003**.

**TS 02.94** "Follow-me, stage 1" is transferred to **TS 22.094**.

TS 22.001, TS 22.002 and TS 22.003 have been updated to cover all of the circuit services and TS 22.060 covers the packet services. It has been agreed that TS 22.101 will be used as the top level document to cover the service aspects for both systems.

TS 22.094 (Follow Me) is considered to be applicable to Private access Networks (for which railway networks are an example) in GSM as well as in UMTS.

The three specifications:

**TS 02.06** Types of Mobile Stations (MS)

**TS 02.07** Mobile Stations (MS) features

**TS 02.40** Procedure for call progress indications

Are no longer relevant and are not required for release 99. The relevant content has been transferred to other specifications.

The specifications still under construction are:

**TS 22.034** HSCSD, stage 1. Draft CR sent for N1/N3 review

**TS 22.060** GPRS, stage 1. Update is awaiting approval of major update of 23.060.

**TS 22.038** SAT, stage 1. Not yet updated for USIM.

**TS 22.043** SoLSA, stage 1. Update is awaiting clarification of SoLSA work status from RAN groups.

**TS 22.078** CAMEL stage 1. Split between CAMEL phase 3 and phase 4 has not been completed.

These specifications are only applicable to GSM rel '99 and remain within SMG1:

- TS 02.56** GSM Cordless Telephony System (CTS) stage 1 description
- TS 02.68** Voice Group Call Service (VGCS); Stage 1(ASCI spec)
- TS 02.69** Voice Broadcast Service (VBS); Stage 1(ASCI spec)

## **Conclusion**

The document structure for GSM and UMTS requirements should be rationalised in the manner described above to provide a unified set of requirements for both GSM and UMTS. To achieve this all of the proposed set of change requests should be supported.

It is intended that this document structure be maintained for Release 2000.
