Issues on Rel99 and before

- **Some corrections done. By default mirror CRs of the changes exist for Rel4 & Rel5.**
- **3 corrections on TS 23.060 (GPRS stage 2) for R99:**
 - IPv6 transport not recommended on Iu and Gn/Gp in R99 and in Rel4 if the whole network is not based on the IPv6 (no mirror CR for Rel5)
 - Clarification of Any Time Interrogation functionality for R99
 - Corrections for Authentication procedures
- **Correction on TS 03.71 (R98) & TS 23.171 (R99) (LCS):**
 - Correction of timing when SMLC enters LOCATION state
- **Correction on TS 23.171 for R99:**
 - Clarification of CS-MO-LR procedures
- **Correction on TS 23.121 for R99:**
 - CS domain signalling requirements: MSC and RNC behaviour relating to handover and cell reselection

Issues on Release 4

No specific work on Rel-4:

- All Release 4 CRs are mirror CRs of Rel-99 changes.

Issues on Release 5

- **Mirror CRs, alignments and corrections on several specifications.**
- **Number of IMS-related CRs on TS 23.228 continues to decrease:**
 - **Still 18 CRs against TS 23.228, but all of these are corrections.**
 - **Main issues and recent decisions are described in more detail on the following slides.**

IMS Progress / Recent decisions

- **Rules for Deriving IMS parameters from the USIM**
 - IMPI, IMPU and Home Network Domain name are to be derived from IMSI in case there is no ISIM application on UICC (i.e., for IMS access with pre-Rel-5 UICCs).
 - Network replies with implicitly registered IMPUs. Temporary IMPU, which is derived from the IMSI, can be barred for all communication.
- **Number of media components per PDP context:**
 - Mechanism simplified: Network can indicate if multiplexing of media components belonging to the same SIP session to the same PDP context is allowed or not.
- **Alignment with the IETF Unify draft has been carried out**
- **Behavior of the UE to support forking has now been covered**
- **IMS open issues:**
 - No clear open issues identified on IMS in Rel5 at this stage

Progress on other Rel5 topics

- **Location Services**
 - Clarification on Rel-5/Rel-6 split for Enhanced User Privacy: TR re-submitted for approval
 - TR proposed to be approved into Release 5
 - Release 5 content has been already agreed to, and included in the Stage 1, Stage 2 and Stage 3
 - Release 6 items are reflected on the LCS Enhancements 2 WID that is for approval at this meeting
- **VHE/OSA**
 - Scope of OSA Rel-5 reduced and aligned with Stages 1 & 3
 - Not much work ongoing in the SA2
- **Shared Networks**
 - SA2 provided feedback to RAN3 but has not yet indicated any clear preference between the solutions that are under discussion at RAN
 - Dialog continues between the groups

 - Work has started on this and first CRs are presented for approval
