### **1. Overall Description:**

T1-SIG would like to thank RAN for the LS on requirement to test non-transmission of newly defined IEs in RRC protocol for Early UE handling.

T1-SIG would like to inform RAN that T1-SIG has agreed to update two representative priority test cases to test that the UE shall not include the newly defined IEs in RRC CONNECTION REQUEST and INTER RAT HANDOVER INFO messages. The current default behaviour of not checking the presence and contents of non-critical extensions shall be left unchanged in all other test cases.

At T1-SIG#27 meeting, test case 8.1.2.1 in 34.123-1 has been updated to test non-inclusion of the newly defined IEs in RRC CONNECTION REQUEST message. T1-SIG has taken an action to update a priority test case to test changes in INTER RAT HANDOVER INFO message.

T1-SIG would also like to advise RAN that the update of the above test cases in 34.123-3 (TTCN Abstract Test Suite) can only be done after upgrade of ASN.1 definition to Dec 02 ASN.1 in 25.331, which is anticipated to be around July 03 time frame.
