1. Overall Description:

At the last SA plenary #25 the Technical Report TR 32.804 on RET Requirements was approved and placed under change control as version 6.0.0 (Rel-6). During the discussion the TSG RAN chairman asked to send the TR to TSG RAN WG3 for review in order to make sure that the TR is aligned with the RAN specifications for the luant interface in series 25.46x.

Therefore, TSG RAN WG 3 reviewed the TR and would like to provide the outcome of the review to TSG SA WG 5 in the attached document R3-041452 which was agreed as the TSG RAN WG 3 opinion at RAN3#45.

In addition TSG RAN WG3 has noted that Annex B in the TR contains information that is not related to current RAN3 WI for RET and also appears to be unrelated to RET. 1. Introduction

During the last SA plenary #25 the Technical Report TR 32.804 on RET Requirements was approved and placed under change control as versino 6.0.0 (Rel-6). During the discussion the TSG RAN chairman asked to send the TR to TSG RAN WG3 for review in order to make sure that the TR is aligned with the RAN specifications for the Iuant interface in series 25.46x.

Therefore, TSG RAN WG 3 was asked to review the TR and report any issues to TSG SA WG 5.

As this review did not happen during the last RAN3 meeting #44, the TR was provided at the RAN3 reflector on the 13th of October 2004 by MCC asking the TSG RAN WG 3 delegates to review the TR and make comments on the RAN3 reflector until RAN3 meeting #45.

This document provides a summary of the comments made by the TSG RAN WG3 delegates.

2. Summary of review comments made on the RAN3 reflector

Comments made by Siemens and Vodafone are given in the attached document and are marked with revision marks.

Except for some editorial changes the following comments/proposals were made:

- Introduction of the new specifications for the Iuant interface in the Scope and Reference section
- Comment on requirement 8) in sub-clause 4.3 whether the requirement is really needed as the scope of the TR in on RET devices
- Removal of the last part of requirement 4) in sub-clause 4.4 as this requirement is already captured in requirement 4) in sub-clause 4.3
- Proposal for Annex A to be removed at all if not really needed, or to be updated according to the information given in TS 25.463 instead of using Annex A of TR 25.802

3. Conclusion and Proposal

A summary of the review comments on TR 32.804 made on the RAN3 reflector until the 10^{th} of November 2004 is given in this document.

Introduction

There has been an initiative to standardize an interface to control Remote Electrical Tilting (RET) antennas. This is an enabler to remotely manage multi-vendor control of RET antennas from a centralised Operations Support System (OSS) via the Itf-N.

1 Scope

The present document defines the requirements for the network wide control of RET antennas via the Itf-N. Two example types of RET antennas are those that are tilted using a mechanical tilting mechanism and those that use a phased array.


The control of RET antennas has been studied in 3GPP <u>TSG</u> RAN<u>WG</u>3 with an approved work item for i Remote Control of Electrical Tilting Antennasî provided in RP-030193 at RAN#19 in March 2003, producing <u>a</u> TR 25.802 [1] and a series of specifications for the new Iuant interface TS 25.460 [8], TS 25.461 [9], TS 25.462 [10], and TS 25.463 [8,9,10,11] approved at RAN#25 in June 2004.

The ability to control Antenna tilt permits cell size to be adjusted, thereby permitting control of up and downlink throughput.

The ability to control Antenna tilts remotely from a network management system permits a network wide perspective to be obtained and for settings to be adjusted in response to predicted population movements, or in response to performance monitoring data to help make the best use of the available radio access network.

Figure 1 shows the main Network Elements (NEs) and depicts the two system contexts A and B where the IRP_aAgent may be located either in the Element Manager (EM), or within the Network Element (NE).

The RET antenna control capability may be achieved either by using one of the two layer 1 options (RS485 <u>cableoption</u> and <u>coax feeder cable-Modem option</u> which permits RET controls to be sent to the tower top equipment via the coaxial feeder) specified in [9].

Requirements for RET control over Itf-N 4

4.1 Fault Management

1) Any fault detected by the RET equipment shall be passed up to the IRPManager.

42 Configuration

The IRPManager shall perform parameters range checking to avoid sending invalid parameters to a RET 1) antenna.

- 2) It shall be possible to define a tilt angle for a single antenna.
- 3) It shall be possible to define the tilt angles for a large number of antennas.
- There is no support for controlled session management i.e. the last configuration command received by the 4) RET equipment will be effective (i.e. last command wins).
- There shall be a capability to 'turn off' Itf-N commands and responses to/from a particular RET antenna to 5) support local maintenance work which may require additional exceptions / notifications.

Editorís Note: This requirement should be more general, relating to all commands and responses on the Itf-N. If a general mechanism exists then this should also be used to block RET commands on the Itf-N. FFS, whether this is a requirement of Itf-N or not.

- 6) The results of configuration changes shall be provided to IRPManager(s).
- 7) The IRPManager may determine if a command is in progress for example device status==locked where a local field engineer has overridden the network manager's configuration capability to the local antenna. Editor's Note: Two somewhat different issues. FFS.
- 8) The failure to configure a parameter shall be returned to the IRPManager making the configuration change. The reason for not configuring a parameter shall also be made available.
- 9) Where an operator finds it necessary the Itf-N will permit the definition of a sets of related values which are applied as near as possible at the same time (this may be of the order of a minute), e.g. a set of Antenna Tilt values for different cells which due to interactions need to be applied closely together. This is necessary so as to coordinate RET settings across the network with other related cell settings such as uplink and downlink parameters, gain settings, and coding allocations.

4.3Static Configuration Management (CM)

- A unique identifier (this may be an RDN combining cell, antenna and other identifiers) is used by the 1) IRPManager to retrieve and configure parameters for a particular antenna. This unique identifier shall be used over the Itf-N interface.
- 2) It shall be possible for the IRPManager to learn of each unique antenna at a remote site via the Itf-N interface.
- 3) The IRPManager shall be able to determine whether an antenna can be remotely tilted or is instead fixed.
- 4) The IRPManager shall be able to determine the compass direction an antenna is facing.
- The IRPManager shall be able to determine the angle of tilt for all antennas at a Node B, with a corresponding 5) UTC time stamp of when the value was obtained.

- 6) The IRPManager shall be able to obtain the valid range of parameters each RET enabled antenna is able to support.
- 7) It shall be possible for the IRPManager to define and retrieve a descriptive label to be associated with any antenna.
- 8) For antennas which are not RET enabled, the IRPManager shall be able to obtain manually entered configuration data.
- 9) The IRPManager shall be able to retrieve diversity information. i.e. which antennas are involved in transmitting the same signal and which antennas are involved in receiving the same signal at the same site.
- 10) The IRPManager shall be able to retrieve the mechanical tilt offset for each antenna. (For RET enabled antennas the mechanical tilt offset provides the baseline from which RET adjustments are made.)
- 11) The IRPManager shall be able to retrieve the latitude, longitude and height of each antenna.

4.4 Maintenance

- 1) The IRPManager shall be able to cause the tilting mechanism to be exercised such that the complete range of tilt is exercised. At the end of the exercise the tilt will be set to a defined value.
- 2) It shall be permitted that settings may be provided by localised maintenance staff using a local craft terminal. Indications of local work shall be provided to remote operation support systems.
- All locally applied settings will be sent to an IRPManager. There will not be any concurrency / resource protection or complex resource locks being used, in terms of any conflicts between local settings and IRPManager settings, the last valid configuration parameter received will persist.
- 4) It shall be possible at the time of a RET installation for the maintenance staff to configure a compass direction which indicates the direction the antenna faces. <u>An IRPManager shall be able to obtain this compass direction setting.</u>
- 5) It shall be possible to log the RET changes.

4.5 IRPManager feedback

- 1) The 3GPP interface for configuring RET will not include performance monitoring data. Where data is required to determine the performance of the network, existing PM techniques and parameters are to be used. Please refer to [2], [3], [4], [5] and [6].
- 2) If any form of bulk configuration is used, the IRP-mManager shall be notified if one or more parameters cannot be applied. The IRPManager may initiate the undoing of all successfully applied settings of a set using the bulk configuration. I.e. the set of system parameters and values are returned to the set of values that existed before the bulk configuration command was started.

5 Issues

Itf-N requirements need to be clearly marked as such in clauses 4.2 and 4.5.

Annex B: Future requirements

This annex is a place holder for requirements which are not within the scope of RET for 3GPP Release 6.

These are provided since considerations for them may ease the future evolution of RET control.

- a) It shall be possible to adjust the gain of Low-Noise Tower Top Amplifiers.
- b) It shall be possible to relate the both tril angle and amplifier gain settings in a way which allows them to be applied as collections of values, which are configured at (as near as possible) the same time.

- c) It shall be possible to determine the current gain and gain settings of Tower Top (TT) Low Noise Amplifiers (LNAs).
- d) It shall be possible to define a number of pre-defined antenna profiles which may be activated at particular times of day (using UTC).

This requirement is FFS. Whether this applies to manager or agent is FFS.

e) The interface will permit several configuration profiles per day to be supported; e.g. it is considered that 4 profiles would be sufficient but absolute number is likely to vary on a case by case basis.

This requirement is FFS.

- 6) It shall be possible to log the RET changes made using a local craft terminal.
- 7) Address the impact of failures. Use back up management systems-?
- Consideration to delegating control to Node B software:
 -ñ aiding network resilience.
 ñ reducing Itf-N signalling.
