# 1 Welcome and Logistics

The meeting was opened by the Chair, Ms Brye Bonner of Motorola. She welcomed the delegates. After introductions Ron Ryan of Nortel Networks welcomed the delegates on behalf of North American friends or 3GPP who are the meeting hosts, and explained the logistics.

**2. Apologies** were received from Jari Haatainen (who will be leaving the Group), Gyorgi Gulbani, Erwin Forster and Martin Kassens.

# 3. Approval of Agenda

The agenda with working schedule in <u>Tdoc S3LI03\_080</u> was proposed by the chair and agreed.

# 4. Nomination and voting for Vice-Chair

Bernd Adams, the existing vice chair, has resigned. Burkhard Kubbutat of MMO2 Germany was nominated as vice chairman and approved by approbation.

# 5. Registration and assignment of input documents

The input documents are listed in Annex C.

# 6. Approval of Report from Vienna

The report from the S3-LI meeting in Vienna 20-22 May 2003 was tabled as <u>Tdoc S3LI03\_081</u>. The report was approved with the following amendment from Marcus Lutz – the conclusion in section 3a should read:

Not to send out the LS for requesting a change of the GTP. 2. Action Point to Ron Ryan and Marcus Lutz to check all Specification (33.106, 33.107 and 33.108) to find places where some clarification has to be added.

# 7. Review Action Points from Vienna

List of action points in <u>Tdoc S3LI03\_081</u> from Vienna.

All the outstanding Action Points were closed with the exception of AP03\_27 on the Chair to advise SA3 on the use of the term ANP in SA3LI. This was completed later in the meeting. The new Action Points are listed in Annex B

# 8. Review outcome of LI and CRs to SA3 and ETSI TC LI

#### 8.1 Liaisons

#### 8.1.1 <u>S3LI03\_073</u> LS to ETSI TC LI.

Liaison was accepted and incorporated into TC LI 003020 spec.

## 8.2 Change Requests

Brad Owen agreed to handle the CRs to SA3 in future.

All the CRs from the Vienna meeting have been accepted by SA3.

## 9. Reports

#### 9.1 SA WG3

Berthold Wilhelm of RegTP tabled the report <u>tdoc S3LI03\_089</u> for information. Selvam Rengasami asked about the procedure and timetable for approval of CRs. Brad Owen confirmed the procedure will allow for two weeks unless there are any major technical changes.

Bernhard Spalt asked about the proposed joint meeting with SA3 in London in November. It seems that their next meeting will now be in Munich so a joint meeting is not possible.

All CRs to be approved by e-mail after LI meeting

#### 9.2 SA report

There was no formal report but Brad Owen reported that SA has frozen release 5

#### 9.3 ETSI TC LI report

In the absence of Gyorgi Gulbani <u>tdoc S3LI03\_099</u> was tabled for information. Peter van der Arend (the chair of TC LI) reported verbally from the Copenhagen meeting that there was no impact on the work in 3GPP LI. He noted the work on the IP services –

There was an LS on aligning the scope. The Chair asked about the objection to referring 33.108 in the ETSI document. This will be checked by the ETSI TC LI Chair and Secretary. It seems that it is referred to in the document and will be normalised at the next meeting in Moscow.

Selvam Rengasami asked about the Global LI workshop. Peter van der Arend responded that the OCG had instructed that following the GSC meeting in Ottawa that ETSI TC LI should organise a

Global Workshop. The intention is to promote ETSI LI standards in the rest of the world especially the Far East. This will be addressed in Moscow. Pierre Truong commented that the standards may be available but they may be reluctant to participate in an open forum (in 3GPP SA2 they have asked that LI is left as a national option).

### 9.4 T1P1.5 report

Ron Ryan of Nortel Networks tabled <u>tdoc S3LI03\_086</u> and commented in addition that 025-B (joint project on packet data) where there are references to 33.108 and GPRS/UMTS. The FBI expressed concern on the lack of packet activity in the CDMA2000 solution. He said that 33.108 r5 is being balloted this month and ballot comments will be resolved in November. The ballot comments on 33.108 will be distributed when he has received them. The FBI expressed concern on the lack a packet activity. They also noted that DDE (Dialed Digit Extraction) is not available.

They have also looked at Wireless LAN for US requirements and given the current WLAN architecture, the expressed conclusion was no new UMTS LI capabilities are needed at this time as the existing capabilities in TS 33.108 appear to be sufficient.

Broadcast MM was also discussed briefly and there were questions on whether support for these services were required as they may be defined as information services. Bernhard Spalt asked about multicast and broadcast services (i.e. to telecoms). This capability is being left open.

Finally on the question of DDE several scenarios were discussed in T1P1 and a number of issues were identified in each scenario. He suggested that this should be done on a per warrant basis. This is addressed again as tdoc S3LI03\_087 and 088.

Two new projects are being proposed by TIA. They are additional LEAS requirements under CALEA and – non required capabilities. These should not impact 3G LI documents.

Work continues on voice over packet in the wired environment.

Selvam Rengasami queried the third bullet point on the existing capabilities for WLAN. Ron Ryan agreed to make a minor deletion and reissue the document as 086r1.

## 9.5 TR-45 LAES

The Chair had tabled <u>tdoc S3LI03\_082</u> as a report but Terri Brooks of Nokia took the opportunity to comment verbally on the status of TR45 LAES.

Two new projects were accepted by the LAES and forwarded for final approval to T1and TIA. The first project is to "produce a new T1/TIA J-STD containing the messaging for support of additional LAES capabilities. Messages should be able to toggle on/off, as implementations of these capabilities are optional and to be provided upon request with negotiated terms. This J-STD assumes a J-STD-025 embedded architecture, messaging and protocol for communications surveillance. This standard is not being developed to meet the requirements of CALEA.

The second project is a revision to J-STD\_025B intended to include CALEA capabilities for new services and standard maintenance following J-STD-025B.

ANSI J-STD-025A has been distributed in published form by TIA on April 16, 2003.

The ballot copy of J-STD\_025B was distributed for information.

#### 9.6 TISPAN (TIPHON)

The inaugural meeting of TISPAN takes place at ETSI HQ on 22 September. Details of the meeting should be available shortly on the ETSI server.

# 12.2.1 Change Request – MSISDN/IMEI clarification for GPRS interception

**tdoc S3LI03\_094** is a CR on TS 33.107 r5 presented by Marcus Lutz of Alcatel and concerns the fact that MSISDN and IMEI is not available all the time in SGSN and GGSN, the interception results may be incomplete, additional clarification have to be added in order to make LI users aware of this fact. Two modifications were proposed.

There was some discussion about the use of target identities in section 5 note 1. It was agreed to amend the note by a revised second sentence. And to note that the MSISDN is applicable to packet switch and to define that target identities apply to the PS domain (i.e. reference to GPRS is deleted).

There were minor changes proposed to section 5.2.

Marcus Lutz will revise the CR and reissue as r1.

There was a proposal by Maurizio Ioviono of Ericsson to put a section into the Service Requirements 33.106. He was asked to provide a section.

<u>tdoc S3LI03\_094r1</u> was re-presented by Marcus Lutz with the amendments and additions and will be further issued as <u>tdoc S3LI03\_094r2</u>

**AP3\_09** Maurizio Ioviono to consider a paragraph for 33.106 for the use of target identities in the PS domain.

**AP03\_11** to amend the incorrect reference to TS101 331 in 33.107 release 6.

# 12.2.2 Change Request – Clarification for GPRS – with MSISDN/IMEI as interception identities

tdoc S3LI03\_100 was presented by Bernhard Spalt of Siemens. This was not accepted.

# 13. TS 33.108 Rel. 5 and Rel. 6

#### 13.1 Updates to Release 5 33108-v.5.4.0

#### Annex G Correction

This was introduced by Selvam Rengasami of Telocardia/FBI <u>tdoc S3LI03\_101</u> and concerned the parameters in the TCP based transport. This was approved.

#### 13.2 Contributions towards Release 6 33108-v.6.2.0

#### 13.2.1 Legal Requirement Adaptation Box

<u>tdoc S3LI03\_090</u> and <u>tdoc S3LI03\_091</u> were presented by Bernhard Spalt of Siemens. He suggested a general solution that could form an informative annex to clarify any special adaptations to confirm with national laws.

Koen Jaspers commented that this was a juridical problem and the filter could be placed with the operator. He did not see a place for it in a technical document. After some discussion it was decided to keep the document in a folder for subsequent review. This would be maintained by the Chair.

**AP03\_10** The Chair to open and maintain a file for ideas for regular review.

tdoc S3LI03\_090 and tdoc S3LI03\_091 were presented by Bernhard Spalt of Siemens. He suggested a general solution that could form an informative annex to clarify any special adaptations to confirm with national laws.

Koen Jaspers commented that this was a juridical problem and the filter could be placed with the operator. He did not see a place for it in a technical document.

After some discussion it was decided to keep the document in a folder for subsequent review. This would be maintained by the Chair.

**AP03\_10** The Chair to open and maintain a file for ideas for regular review.

#### Meeting Note – CS Section in 33.108

Under r5 there was a reference to the ETSI CS domain. The reference was removed and whole text from 201 671 was inserted. It now seems that the CS part has not been properly addressed in 33.108. This was discussed in TC LI and their response was considered in Vienna. There were four issues to be considered. These are dealt with below.

#### 13.2.3 Change Request – Sending of HI1 notification

This was presented by Marcus Lutz of Alcatel as <u>tdoc S3LI03\_095</u> and deals with the sending of HI1 notification and concerns the backward compatibility to R5. The Proposed amendments are to Annex B7. As this had previously been consciously omitted due to our work item no action was taken.

#### 13.2.4 Change Request - User data packet transfer

This was presented by Marcus Lutz of Alcatel as <u>tdoc S3LI03\_096</u> and concerns the references to user data packet transfer. It ensures backward compatibility and proposes additional sections in annex A1 and B6. After several amendments this will be reissued after clarification of the ASN.1 tree.

#### 13.2.5 Change Request – IRI Parameters clarification

This was presented by Marcus Lutz of Alcatel as <u>tdoc S3LI03\_097</u> and concerns clause 5.2. It proposes to explain some of the HI2 ASN.1 parameters. This had no support and no action was taken.

#### 13.2.6 Change Request – LI Management Operation

This was presented by Marcus Lutz of Alcatel as <u>tdoc S3LI03\_098</u> and concerns LI management ROSE operations and proposes amendments to Annex B.5. ASN.1. During the discussion it was decided to renumber and reassign the B.3 sections. 098 will be reissued after consultation with Manfred Beirer.

## 13.2.7 Change Request – LI Reporting of Dialled Digits

Two documents were presented by Ron Ryan of Nortel as <u>tdoc S3LI03\_087</u> and <u>S3LI03\_088</u>. In <u>tdoc S3LI03\_087</u> He proposed methods of dialled digit extraction. He described the various proposals – at the SGSN, PSTN Gateway (IMS-GW) or at the delivery function. In the first case he concluded that multiple codecs would be required where they are not needed for any other purpose. In the second case there is only a partial solution. In the third case more resources are required (i.e. codecs) where content collection is not authorised. In summary he suggested that the major issue was that of codecs and one solution would be that the entire content stream should be sent to the LEMF (where the warrant requires DDE) as the codecs are already in place. Concern was expressed that some of the proposed solutions over-provided and that only reasonable product should be forwarded. He also noted that some manufacturers do not have a separate DF.

**tdoc S3LI03\_088** is a change request for 33.108 R6 to insert text in Annex H to support DD reporting where it is done on a per authorisation basis by directing the media stream to the LEMF. This was accepted as modified and will be reissued as R1.

tdoc S3LI03\_088r1 was later re-presented by Ron Ryan and accepted

#### 13.2.8 Annex G Correction

This was introduced by Selvam Rengasami of Telcordia/FBI as <u>tdoc S3LI03\_102</u> and concerned the parameters in the TCP based transport. This was approved.

#### 13.2.8 Identification of LEMF address

This was introduced by Selvam Rengasami of Telcordia/CICS as <u>tdoc S3LI03\_103</u> and proposes enhancements to 33.108 to support the Network Operator selection of an LEA Address when there are multiple addresses to choose from for delivering content. After considerable discussion it was decided to defer the proposal until the November meeting. However the attached Change Request was reviewed in some detail and some amendments made. It was decided to add some examples on where this can be used.

# 13.2.9 Draft LS to ETSI TC LI to Update of scope in 102 232 to conform with 33.108

This was introduced by Bernhard Spalt of Siemens as <u>tdoc S3LI03\_104</u> and proposes that the IP handover specification in TC LI be amended. This was agreed.

# 14. Continued Discussion and New Business

#### 14.1.1 Code of Conduct

This was presented by the Chair, Brye Bonner, as document <u>tdoc S3LI03\_083</u>. It proposed guidelines for delegates in regard to laptops and documents. It included an article on laptop protection from Charles Brookson. It was agreed that the start of every meeting will include an IPR statement and a reference to the Code of Conduct.

#### 14.1.2Liaison to SA3

This was presented by the Chair, Brye Bonner, as <u>tdoc S3LI03\_084</u> and is a draft liaison statement to SA3 on the use of the ANP acronym by the LI group. (ref 6.2 in Vienna Report).

This was approved for forwarding to SA3.

# 15. Review meeting output

15.1 Change Requests.

CRs 88, 94 101 102. It was agreed that these will not be put on the SA3 e-mail exploder until the week after the SA3 meeting (SA3 approval will be by e-mail over a fortnight period).

# 16. Discuss November meeting agenda, work plan
