### **RE: LS out on coordination of IMS NRM changes**

Dear Mr. Toche,

3GPP2 TSG-S WG5 intends to continue the harmonization efforts regarding the IMS NRM IRP. We are planning to directly reference and reuse relevant 3GPP R7 IMS specifications (3GPP TS 32.732, 3GPP TS 32.733, 3GPP TS 32.735). To help us achieve this reuse, updates to these specifications need to be validated by both parties.

Earlier this year we began discussions in this regard in IMS harmonization conference calls, and we need to come to conclusions.

We would like to discuss with 3GPP SA5 how to handle changes to the IMS NRM IRP specifications on entities common to the two organizations.

We need to discuss such items as:

- How CRs are sent to 3GPP2 TSG-S WG5 for validation, and how comments are returned.
- The timeframes for CR creation, CR validation, and CR approval in relation to 3GPP SA5 working group meetings.
- The entities subject to this coordination are the following IOC: AsFunction, BgcfFunction, CscfFunction, ImsMgwFunction, MgcfFunction, MrfcFunction, MrfpFunction, SipAsFunction, and link IOCs between these entities. The entire CORBA IDL and XSD files will be used by 3GPP2.

We welcome 3GPP SA5 to set up a conference call at your convenience to discuss these items.
