Cooperation and Coordination

As result of discussion regarding the role of the ITU-T in the generation of mobility standards, including IMT 2000 standards, the ITU-T TSAG has concluded that communication between the 3GPP and the ITU-T needs to be improved. Currently, ITU-T communication with the 3GPP involves the routing of any ITU-T communication statements routed through a 3GPP partner SDO (e.g., ETSI), and it is our understanding that 3GPP communication with the ITU-T is similarly constrained. In today's **telecom environment**, with its need for rapid development of **standards in** response to market needs, TSAG believes a mutually agreed set of communication procedures would improve the ability for cooperation. You may wish to note **an** example of a **similar** cooperative arrangement wherein the ISOC/IETF and the ITU-T mutually agreed to a set of **communication** procedures **in** 1998. It is our belief that since ETSI, Committee T1, and TTC are ITU-T qualified organizations under Recommendation A.6, a simplified set of procedures applying to communication **between** the ITU-T and 3GPP maybe possible.

Thus, we request that ETSI, Committee T1, and TTC bring **this** proposal before the appropriate 3GPP body for discussion and action. Assuming a positive reply, we suggest a small group **including representatives/participants from** the ITU-T and your organization, and the 3GPP leadership, informally prepare a proposal that maybe submitted to the ITU-T WTSA at the end of September 2000.

For your information we have submitted an identical request to T1A and TTC for transmittal to 3GPP2.
