## Issues on Rel99 and before


- GPRS stage 2 (TS 23.060)
  - Unsynchronous UTRAN and UE RRC states can cause the UE to be unreachable for MT CS calls and MT SMS. A mechanism to recover this situation is introduced.
  - It is clarified that the SGSN should not send the packet flow identifier to an MS that do not support the BSS packet flow procedures

## Issues on Release 5 (1/2)

- In addition to mirror CRs of R99 and Rel4 changes:
  - UMTS QoS (TS 23.107)
    - Clarification on which RAB attributes that are valid for GERAN (MCC is also asked to delay the implementation of the corresponding R6 CR until an R6 version of 23.107 is created)
  - Early UE (TS 23.195)
    - Removal of a note in the scope section
    - See also LS from SA2 (SP-030667)

- GPRS (TS 23.060):
  - Clarification that the SGSN should send the MCC and MNC to the GGSN (see also LS from SA2 asking SA to decide if the same changes shall be done in earlier releases)
- IMS (TS 23.228):
  - Clarification on handling of sessions without required capabilities
  - Clarification of trust domain restrictions
- LCS Stage 2 (TS 23.271):
  - Addition of positioning method used
  - Addition of LDR reference number

#### Maui, U.S.A., 15-18 December 2003 **Rel-6 work item status (1/6)**

- MBMS Stage 2
  - 14 CR's agreed: e.g. general clarifications and corrections, introduction of GERAN aspects, correction of procedures etc..
- Push Services Stage 2
  - Discussion on the conclusions have started but are not completed
- Network Sharing Stage 2
  - The broadcast-channel-based solution for network selection for UTRAN has been adopted as a working assumption
- System architecture (TS 23.002)
  - Introduction of the Gq Reference point

## Rel-6 work item status (2/6)

- Location Services Stage 2 (TS 23.271)
  - 11 CRs agreed on TS 23.271:
    - E.g. LCS QoS class, Privacy and Charging related updates, Updated reference, optional sending of Cell id/SAI to GMLC, etc...
- GUP Stage 2 (TS 23.240)
  - Agreement and CR on the information model, CRs adding Notification reference and Subscription status, selecting server mode of operation etc.
- PS Domain and IM CN Subsystem support for IMS Emergency sessions (TR 23.867)
  - Contributions on the USIM less establishment of GPRS PDP context and translation of SIP URI's to routable numbers (when connecting to EC in PSTN)

# Rel-6 work item status (3/6)\* GLOBAL INITIATIVE

- IMS Phase 2
  - 14 CRs agreed to TS 23.228:
    - E.g. on messaging, Hold and resume, Handling of PSI's, Forking, User preferences and terminal capabilities, Trust domain clarifications

#### • IMS Commonality and Interoperability

- Commonality already done, no contributions in on interoperability and it is assumed that no more work will be done in 3GPP on this item and it can hence be marked as completed in the workplan
- Policy control/Gq:
  - CR on 23.207 to generalize the PDF/AF

## Rel-6 work item status (4/6)

- GPRS Stage 2
  - Rel-6 changes to TS 23.060:
    - Security for Multiple PDP contexts
    - Indicating teardown in deactivate PDP context accept
    - BSS paging coordination description
    - SGSN behavior on BSS downgraded ABQP
    - BSS PFC procedures at PDP context modification

#### IP Flow Based Bearer Charging Evolution

- Gz and Gy interfaces ready for SA5 work to start
- A related LS (SP-030668) clarifies what aspects require further development in SA2 and it is also recommended that the flow based charging function should be captured in a new TS.

## Rel-6 work item status (5/6)

- WLAN
  - TSG SA is asked to decide if the WLAN TS 23.234 shall be approved or not
  - The WLAN TS 23.234 is not sent in the "normal" approval package but in an LS (SP-030664) that provides more background information and also feedback on the issues raised at SA#21
  - At SA2#36 a majority of the companies felt that 23.234 is ready for approval while some companies felt that SA2 should wait for further input from GSMA before asking for approval
- BARS
  - TR 23.977 is sent to SA#22 for information



## Actions expected from SA#22 by SA2 (7/7)

- Questions for Advice:
  - Flow based charging, see LS SP-030668
    - SA#22 is asked to endorse the creation of a new TS that capture the overall high level functionality and architecture impacts of flow based charging
    - If agreed SA2 will perform the necessary updates of the WID
  - Early UE handling, see LS SP-030667
    - SA#22 is asked to resolve the last open issue in 23.195 i.e. to decide if the transfer of UESBI-Iu is applicable on the A interface (alternatively SA can defer the decision to GERAN)
