Rémi THOMAS (39) graduated from the "Ecole Nationale Supérieure des Télécommunications " (Paris) in 1982.

He joined CNET the R&D centre of France Télécom in 1983, where he worked on dimensioning problems based on stochastic modelling.

Then, in 1987, still at CNET, he joined the "Marathon" project which purpose was to specify the radio interface of a digital mobile network and to contribute to the GSM standardisation. Since 1987 he has been deeply involved in the standardisation of the GSM system, in particular he actively contributed to the GSM protocols aspects in SMG3.

Inside France Télécom, he was in charge of specification aspects (services and dimensioning) of the first France Télécom GSM networks; then in 1994 he was in charge of the France Télécom DCS 1800 field trial.

R. THOMAS represents France Télécom at the plenary of the ETSI Technical Committee SMG. Since 1995 he has also been chairman of SMG7 which is the STC of ETSI in charge of the mobile station test specifications for GSM. During his chairmanship of SMG7, the type approval specifications for GSM phase 2 were completed and conformance specifications for phase 2+ were developed.

R. THOMAS is responsible for the co-ordination of the France Télécom inputs to the STCs of SMG and to the TSGs of 3GPP.
