Abstract of document:

This specification is the first part of a multi-part specification describing in prose a suite of conformance tests for 3rd Generation User Equipment (UE). The tests are intended to ensure that User Equipment for 3GPP systems conform to the relevant 3GPP Technical Specifications.

The other parts of the multi-part specification are TS 34.123-2, which contains a pro-forma for the Implementation Conformance Statement (ICS), and TS 34.123-3, which contains a detailed and executable description of the test cases written in a standard testing language, TTCN.

Changes since last presentation to TSG Meeting #:

Outstanding Issues:

The test cases included in the specification are generally as complete as is practical, taking into account the status of the core 3GPP specifications the test case depends upon. These test cases will be revised once the release 99 version of the relevant core specification becomes available.

The test cases that are not yet included in the specification are scheduled for inclusion before June 2000.

A more detailed report of status is attached to this cover document.

Contentious Issues:

Timely completion of this specification depends upon the availability of the core specifications for which it provides conformance tests.

Specifications with the largest impact are TS 24.008, TS 24.331, TS 24.321 and TS 24.322.
