## 1. Overall Description:

This LS is for ACTION by TSG-T. TSG-T is requested to kindly intercede on behalf of T2 with TSG-SA and thereby with S1 and S2.

This LS presents a request for ACTION on the topic of overall GUP-related work coordination among various WG's. Attention is called to other LS's from T2 which focus on specific topics within the overall topic of GUP work. T2-020114 focuses on the relation of Subscription management and GUP. T2-020255 focuses on GUP/DDF timescales. T2-020254 focuses on coordination of data definitions, identified in GUP development.

T2 is currently examining the working procedures for the GUP T2 Stage 2 and Stage 3 work, with the objective of establishing an effective and efficient process that allows the maximum coordination between related WGs. For this to occur, it is imperative that the roles, scopes and responsibilities of these WGs are clearly defined and that the work of these groups is constrained to these defined scopes and responsibilities.

T2 recognises that aside from the GUP S1 Stage 1 Service Requirements, T2 Stage 2 & 3 and S2 Stage 2 specifications, there are additional work items currently being developed at other WGs that are understood to also affect and be affected by the GUP work.

T2 has received requirements affecting GUP functionality from other WGs (e.g. S5). However, these requirements do not appear to be identified at a higher level in the GUP Stage 1 Service Requirements specification. While T2 is committed to its role in defining the data descriptions and identifying common objects relating to the GUP work, T2 would like to re-emphasize that the overall requirements from all WGs should be, and need to be, coordinated by S1. T2 is aware of the urgency of the work in these other WGs, but we would prefer that such requirements were first considered at a higher level by S1. T2 wishes however, to mention that many of the requirements involve work which is far too great to fit inside the required timeframes, and thus requires either a prioritisation or a phasing of those requirements. (This last issue affects more areas than just GUP).

Given the obvious broad scope of the GUP work, T2 would like to invite S1 to additionally consider other requirements from all the relevant WGs and to advise T2 and the other affected committees accordingly.

## 2. Actions:

T2 requests TSG-T to bring the following ACTIONs to TSG-SA for consideration by SA1 and SA2 -

To Request S1 group to kindly consider the points about the roles of the working groups involved in, and affected by, the GUP work.

To Request S1 group to kindly develop coordinated realistic requirements for all groups. . . . .
