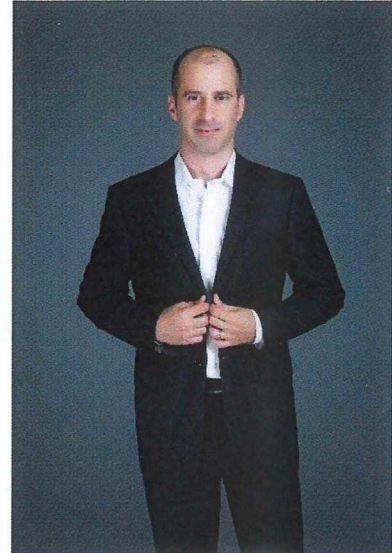


## Curriculum Vitae: David Mazzaresse

### SUMMARY

David Mazzaresse received the engineer degree in Electrical Engineering from ENSEA, France, in 1998, and a Ph.D. in Electrical Engineering from the University of Alberta, Canada, in 2005.

He then worked as a senior engineer in the global standards and research group of Samsung Electronics in South Korea, from 2005 to 2010. He joined Huawei Technologies in April 2010 as a senior expert and 3GPP standard delegate.



### EXPERIENCE

He has been actively participating in IEEE 802.22 (holding the secretary position), IEEE 802.16m (acting as MIMO session chair), ETSI BRAN, and since 2010 in 3GPP RAN1 as well as TSG RAN since 2013.

He has covered LTE-Advanced releases 10 to 17, and NR releases 14 to 17. He was co-rapporteur of the LTE release 11 work item on CoMP, and co-rapporteur of the study item and work item on LTE-LAA in release 13. He has served as feature lead for NR-U (HARQ and scheduling enhancements) during release 16, and has chaired offline sessions in both RAN1 and TSG RAN.
