Dear Susanna and Andrijana,

On behalf of Dolby Laboratories, Inc., an ETSI member of 3GPP, I am pleased to nominate Mr. Frédéric Gabin as candidate for the position of 3GPP TSG SA WG4 (SA4) Chair at the upcoming election at SA4#123-e 17-21 April 2023.

Frédéric was elected as SA4 Chair in September 2016, re-elected in October 2018 and April 2021 and continued to serve as MBS SWG Chair. Frédéric has been trained to comply with all applicable antitrust/competition laws and regulations while acting in his capacity as TSG WG Chair. Under his leadership the working Group achieved completion of Rel-14, Rel-15 (5G Phase 1) and Rel-16 (5G Phase 2), Rel-17 and initiated the Rel-18 work. Over this period, three delegates received the 3GPP excellence Award and several workshops with other industry organizations took place. Over the last 3 years the group successfully adapted to the pandemic. In 2022, 3GPP SA4 and Frédéric received an Emmy Award for the work on HTTP Streaming. 3GPP SA4 Rel-17 work included the following selected features:

- 5G Media streaming architecture and stage 3 extensions on AF Event Exposure (EVEX) and Edge (5GMS_EDGE_3);
- 5G Multicast-Broadcast User Service Architecture and Stage 3 and related 5G Media Streaming Extensions (5MBUSA);
- 8K Television and 8K VR 360 Video over 5G;
- Immersive Teleconferencing and Telepresence for Remote Terminals (ITT4RT);
- Extension for headset interface tests of UE (HInT).

Frédéric has the full commitment of Dolby in terms of both time and resources required to perform the duties of this SA4 leadership position. If elected, Dolby will ensure that Frédéric maintains impartiality and acts freely in the interests of 3GPP, independent of individual company interests, in his capacity as Chair of SA4.
