Yannick has over 15 years' experience in the mobile communications industry, including 10 years' involvement in 3GPP. Before joining LG Electronics in June 2014 as Senior Standards Engineer, he has been working for NEC from 2000 to 2014, and for Alcatel from 1998 to 2000.

In 2015, Yannick has been fully committed to SA6 activities and MCPTT work. Since he took over Rapporteurship for MCPTT in April, he has been leading the work on 3GPP TR 23.779 and 3GPP TS 23.179 till successful completion for Rel-13. He has efficiently organized the work, in particular via several conference calls between meetings, and has provided regular support to SA6 leadership team.

From 2006 to 2014, Yannick has been a regular and active attendee of 3GPP TSG CT WG1. He has been leading NEC's delegation and mainly contributing to the specification of SAE and CS Fallback.
